Square Peg Foundation rescues retired horses from racetracks and retrain them to work in our adaptive riding program that specializes in working with families affected by autism. Square Peg has achieved international recognition both in the work with the ex-racehorses and in our work with International organization New Trails Learning System, a world leader in using horses with people with autism. Square Peg is 1 of 64 organizations in North America to be fully accredited with the governing body of Thoroughbred Aftercare Alliance. At considerable expense, Square Peg houses, feeds, retrain, and rehabilitates ex-racehorses. Some horses cannot be fully physically rehabilitated and they are given sanctuary at Square Peg's ranch. Some are adopted to pet owning and sporting homes, and the rest work in our adaptive riding program. Due to the tripple mission of the organization (horses being a critical component of each) it is not possible break out expenses by mission.

Total program expenses include horsecare, ranch related costs, program salaries, and training for adult autistic job trainees.
