DUE TO THE PANDEMIC, REQUESTS FOR SERVICES INCREASED DRAMATICALLY IN MARCH 2020 WHICH RESULTED IN SERVING 258,933 MEALS IN THE LAST FOUR MONTHS OF THE FISCAL YEAR ALONE. ALTHOUGH THE PANDEMIC REQUIRED MANY MODIFICATIONS TO SERVICE DELIVERY METHODS, COVENANT SOUP KITCHEN SERVED ONSITE MEALS, AS WELL AS OFFSITE MEALS TO HOMELESS AND HOMEBOUND GUESTS AND WAS OPEN EVERY DAY OF THE YEAR FOR BREAKFAST AND LUNCH AS WELL AS FOR DINNERS ON FRIDAYS. THE FOOD PANTRY WAS OPEN MONDAY - SATURDAY AND BY APPOINTMENT.
