OUT Maine works toward a welcoming and affirming Maine for all rural young people of diverse sexual orientation, gender expression and gender identity. In partnership with their allies and families, OUT Maine supports, educates and empowers these youth in their journey from adolescence to adulthood.

Creating safe and validating spaces and leadership training for queer youth that provide emotional support, acceptance, visibility and connections. Includes weekly programming, overnights throughout the state, weekend retreats, annual Rainbow Ball weekend at Camp Kieve Wavus for 200 queer youth from around the state, biannual LGBTQ+ Studio Immersion Weekend at Haystack Mountain Schools of Crafts, attending state leadership conferences, building and supporting a Youth Policy Board that is working on improving mental health through inclusive queer sex education in schools.

Building safe schools through an integrated school climate initiative which includes consultation, review of and recommendations of school policies, the development and support of Gay/Straight/Trans Alliances (GSTAs) in schools, which are safe clubs for queer youth and their allies, student education, and staff trainings. A study from British Columbia released in 2015 (22,000 youth participated from 92% of the provincial high schools) showed that schools with GSTAs for 3+ years had a 50% reduction in bullying and harassment for ALL students. Thus, OUT Maine has prioritized the building of this safety net in Maine's rural schools as well as developed an integrated school climate approach to help schools create safety and affirmation in the overall school environment.

Weaving a rural provider safety net by training doctors, nurses, mental health providers, clergy, crisis workers and youth service organizations on the specific needs of LGBTQ+ youth and how to support them. Training offerings range from 2-3 hour programs through a full day training for providers working with youth over time. Over 8,000 providers have been trained in the last five years and OUT Maine continues to expand this network through its trainings in all 16 Maine counties.
