Eligible candidates must have the following criteria to apply: demonstrated financial need, and good academic standing (80% GPA and above). The amount of each individual grant varies from year to year based on individual need and financial resources available to HPAC. Contracts cover Tuition, uniform, school supplies, but not registration fees. Hunts Point Community Partnership Academic Grant: In an effort to assist in alleviating financial burdens for families associated with academic expenses, the Hunts Point Community Partnership offers an Academic Grant. Applications may be submitted to cover tuition, educational activities, summer camp and transportation for summer employment or activities. Complete applications are reviewed on a rolling basis and recipients must reside in Community District 2. Family Project Emergency Grants: As part of Covid Relief, the Hunts Point Alliance for Children Family Project offers emergency grants for items such as rent, food, utilities, storage, diapers, and other emerging needs. Eligibility is determined by families having a child enrolled in HPAC programming (early childhood through college) and providing supporting documentation. Grants made on rolling basis beginning in May 2020.
