We break these cycles by helping them: develop skills; experience positive relationships; and prepare for independent living. Additionally, we provide comprehensive family therapy for those young men who are returning to their families. Of Bonnie Brae's entire population: approximately 34% are African American; 30% are Caucasian; 30% Latino; 5% Biracial, and 1% Asian. When boys arrive at Bonnie Brae: 74% have had multiple school suspensions; 68% have been abused, neglected or witnessed violence inside or outside the home; 52% are on psychotropic medications; Despite this, after 12-18 months at Bonnie Brae, 100% of all eligible students graduate from our program. Bonnie Brae defines successful discharge as being discharged to a less restrictive setting which captures our ability to help these boys stop their downward spiral. Of alumni surveyed that were discharged between July 2015 through December 2016: 87% were enrolled in high school or graduated; 58% were working; 49% have had no contact with the Justice System; 47% were living in the community; 10% were enrolled in post-secondary education (community college, university, or trade school).
