COPIES OF UWMOC'S MOST RECENT AUDITED FINANCIAL STATEMENTS SHALL BE MADE AVAILABLE TO ANY MEMBER OF THE PUBLIC WHO SO REQUESTS. REQUESTS FOR COPIES SHALL BE MADE IN WRITING OR ELECTRONICALLY TO UWMOC INDICATING THE NAME AND ADDRESS OF THE REQUESTORS. RESPONSES TO SUCH REQUESTS SHALL BE MADE BY UWMOC WITHIN THREE BUSINESS DAYS OF RECEIVING THE REQUEST. UWMOC MAY CHARGE A FEE OF \$.20 PER PAGE TO COVER THE COSTS OF PRINTING AND MAILING THE AUDITED FINANCIAL STATEMENTS. SUCH FEES MAY BE WAIVED AT UWMOC'S DISCRETION.
