Our Literacy Arts program, Her Words, benefitting challenged high school students, continued uninterrupted through the end of July changing from in person to virtual sessions. Morris Arts is committed to creative placemaking projects. Creative placemaking is when partners from the public, private, non-profit and community sectors strategically shape the physical and social character of neighborhood, town, city or region around arts and cultural activities. Creative placemaking animates public and private spaces, rejuvenates structures and streetscapes, improves local business visibility and public safety and brings diverse people together to celebrate, inspire and to be inspired.
