Capacity building: MAZON provides funding, technical assistance, trainings, and other resources to nonprofit organizations in some of the most food insecure states in America, and throughout Israel, building leadership capacity within the anti-hunger and Jewish communities to participate in advocacy. MAZON's partners work at the local, state, and national levels to remove barriers to participation in food assistance programs and champion responsible government policies to prevent widespread hunger in the future. FY 2020 Highlights: 1. Funded 7 rapid-response, anti-hunger projects in 6 states and Washington, D.C. through MAZON's quick reaction fund. 2. Provided 24 supplemental COVID-19 response grants to existing emerging advocacy fund grantees. 3. Funded 30 anti-hunger organizations to secure and maintain staff positions in 13 of the most food-insecure states through the emerging advocacy fund, and 2 grants to partner organizations in Indian Country. Supporting public policy, organizing, research, and community relations roles. In some cases, MAZON's investment supports the only full-time anti-hunger advocate in the state. 4. Continued to educate policymakers on MAZON's provision included in the House National Defense Authorization Act to address hunger among currently-serving military families through the establishment of a military family basic needs allowance. 5. Developed a 50 state hunger resource guide for those who are experiencing hunger during the COVID-19 pandemic. 6. Held a town hall on college hunger. 7. Hosted a campus round table. 8. Submitted comments to USDA on proposed regulation to revise categorical eligibility for SNAP. 9. Submitted and cooling all allowances. 10. Submitted comments
