RESOURCES WERE ALSO COMMITTED TO THE GREATER MERCER PUBLIC HEALTH PARTNERSHIP (GMHP) SO THAT SFMC COULD ACTIVELY PARTICIPATE IN ITS 2019 COUNTYWIDE CHNA AND CHIP PROCESS. STAFF WERE ASSIGNED AND PLAY AN ACTIVE ROLE IN THE GMHP SERVING ON ITS BOARD AND VARIOUS SUB-COMMITTEES. IN AN EFFORT TO PREVENT THE SALE OF ALL FLAVORED E-CIGARETTES TO TRENTON CHILDREN, SFMC CONTINUED TO WORK WITH OUTSIDE ORGANIZATIONS, INCLUDING THE HUNTERDON MERCER REGIONAL TOBACCO COLLABORATIVE, THE NEW JERSEY QUIT LINE, MOMS QUIT CONNECTION, TOBACCO-FREE FOR A HEALTHY NEW JERSEY, OUR CONCERNED PASTORS ORGANIZATION AND OUR HOSPITAL EMPLOYEES. SFMC HAS BEEN AN ADVOCATE OF ALL BILLS THAT WOULD CURTAIL THE SALE AND USE OF VAPING AND E-CIGARETTE PRODUCTS IN THE STATE, FOLLOWING MORE THAN 2,000 CASES OF VAPING-RELATED ILLNESS NATIONWIDE AND 39 DEATHS SPANNING 24 STATES. RESEARCH HAS SHOWN THAT FLAVORED ELECTRONIC SMOKING DEVICES AND PRODUCTS, SUCH AS MINT, CANDY, FRUIT AND CHOCOLATE ARE EXTREMELY APPEALING TO CHILDREN. IN JANUARY 2020, NEW JERSEY BECAME THE FIRST STATE IN THE NATION TO IMPOSE A PERMANENT BAN ON ALL FLAVORED VAPE PRODUCTS, INCLUDING MENTHOL. ADVOCACY FOR S3265 WAS ENDORSED WITH APPEARANCES AT THE STATE HOUSE. TRANSFORMING COMMUNITIES INITIATIVE (TCI) IS A FIVE-YEAR POPULATION HEALTH PROJECT FUNDED BY TRINITY HEALTH TO ADDRESS POLICY, SYSTEM, AND ENVIRONMENTAL CHANGE AND TO PROMOTE HEALTHY BEHAVIORS. TCI WAS DEVELOPED AS A KEY STRATEGY OF TRINITY HEALTH'S PEOPLE-CENTERED 2020 COMMUNITY HEALTH AND WELL-BEING STRATEGY, FOCUSING ON SIX HEALTH ISSUES RELATED TO POOR DIET, PHYSICAL INACTIVITY, TOBACCO USE, CHRONIC DISEASE AND OTHER SOCIAL DETERMINANTS OF HEALTH. TRENTON, THROUGH TRENTON HEALTH TEAM (THT), IS ONE OF SIX COMMUNITIES SELECTED NATIONALLY TO IMPROVE LOCAL PUBLIC HEALTH AND WELL-BEING, ALONG WITH SPRINGFIELD, MASSACHUSETTS; MAYWOOD, ILLINOIS; MONTGOMERY COUNTY, MARYLAND; BOISE, IDAHO; AND SYRACUSE, NEW YORK. THE SIX REQUIRED INTERVENTIONS ARE: (1) TOBACCO 21- WWW.TOBACCO21.ORG/, (2) COMPLETE STREETS - WWW.SMARTGROWTHAMERICA.ORG/COMPLETE-STREETS, (3) IMPLEMENTATION OF NUTRITION STANDARDS IN EARLY CHILDHOOD SETTINGS (DAYCARE AND HEAD START), (4) BREASTFEEDING POLICY ENHANCEMENT, (5) SCHOOL BOARD POLICY TO ENHANCE PHYSICAL ACTIVITY IN SCHOOLS, AND (6) FOOD AND BEVERAGE STANDARDS/COMPETITIVE FOODS POLICIES. IN AN EFFORT TO ADDRESS THE ASPECT OF ALCOHOL AND SUBSTANCE ABUSE AS SOCIAL INFLUENCERS OF HEALTH, SFMC ADDED TWO IMPORTANT QUESTIONS TO THE REGISTRATION QUESTIONNAIRE IN THE EMERGENCY ROOM RELATED TO USAGE. THESE QUESTIONS WERE ADDRESSED BY THE TRIAGE NURSE AND ENTERED INTO THE COMPUTER SYSTEM. ANY POSITIVE RESULTS REQUIRED THE NURSE TO GIVE THE PATIENT A RESOURCE FORM AND A REFERRAL TO A LOCAL AGENCY. IN 2019 THE HOSPITAL, IN COLLABORATION WITH THT, BEGAN TO UTILIZE A SYSTEM KNOWN AS NOWPOW. THIS SYSTEM IS A NEW WAY TO ADDRESS SOCIAL DETERMINANTS OF HEALTH. IT ALLOWS SFMC TO CLOSE THE LOOP ON REFERRALS MADE WITHIN THE SYSTEM OF RESOURCES. THE NOWPOW SYSTEM ALLOWS THE HOSPITAL TO: - SEARCH WITHIN A CARE-SOURCED RESOURCE DIRECTORY TO LOCATE LOCAL HEALTH AND SOCIAL SERVICES IN OUR IMMEDIATE COMMUNITY- BETTER SUPPORT PATIENT CARE BY USING PRINT, TEXT AND EMAIL IN MULTIPLE LANGUAGES (SPANISH, CHINESE, ARABIC, KOREAN, POLISH AND SOMALI)- CLOSE THE LOOP ON REFERRALS BY UTILIZING A BI-DIRECTIONAL PLATFORM TO REDUCE CALL AND EMAIL TRAFFIC AND SEND APPOINTMENT REMINDERS VIA TEXT OR EMAIL IN MULTIPLE LANGUAGES.- MEASURE THE IMPACT OF THE REFERRAL SYSTEM BY GATHERING IMPORTANT STATISTICS FOR DASHBOARD USAGE.
