This process evolved regionally to include each respective communities previous successes and lessons learned in conducting CHNAs. For example, York and Adams counties had been conducting CHNAs for 20 years and had extensive expertise to share related to primary data collection. The system-wide approach to the CHNA enabled WGS to collect primary data from Lebanon County residents, share it with key community, hospital and system leaders, and integrate it into the system-wide and entity-level planning processes. A representative sample of 470 Lebanon County adults were interviewed between March 26 and May 13, 2018 using survey questions derived from the Behavioral Risk Factor Surveillance System (BRFSS), a validated survey tool utilized by the Centers for Disease Control and Prevention (CDC), and organized into four categories: healthcare access, behavioral risk, health conditions, and prevention behaviors and context. Supplemental secondary data from the Robert Wood Johnson Foundation (RWJF) annual County Health Rankings and from the Pennsylvania Department of Health was also integrated into the 2018 CHNA. The 2018 CHNA planning process engaged a wide range of community organizations serving the diverse interests of all partners. The intent of the CHNA was to collect adequate valuable data and information that would satisfy the needs of all participating organizations, without burdening CHNA respondents with too many questions. Committee members reviewed questions asked in the 2015 CHNA and edited accordingly based on the current health care environment and areas of interest. The CHNA was developed utilizing consulting support and guidance through a contract with the Floyd Institute for Public Policy at Franklin and Marshall College. The collaborative efforts of the community stakeholders determined the survey questions to be asked of the community; discussed data collection methodology, including sample size and method of obtaining data; reviewed the raw data and supporting charts/ graphs; identified potential community health priorities, and; developed the process by which results and priorities were to be shared with the community. Data collected and analyzed by the Floyd Institute for Public Policy included breakdowns by age, gender, geographic area, race/ethnicity, and income level, and enabled the development of charts/graphs focused on: quantity of residents affected; health risks and disability-adjusted life years; correlates of obesity and depression (two significant health priorities); health disparities, and; social determinants of health impact. This information is included in the 2018 Community Health Needs Assessment Summary Report available at www.wellspan.org. CHNA results and related priorities identified by the Community Health Council of Lebanon County and other pertinent community stakeholder groups were shared with the system-wide Planning Committee at WellSpan Health, a Committee comprised of community members and leaders that represent each of WellSpans primary entities and service areas, in addition to corporate leadership. Planning Committee members reviewed the CHNA data, and designated system-wide priorities as: Care for all, including a focus on access to care and health equity; Behavioral health and lifelong wellness, which would incorporate behavioral health, substance use and addiction and lifelong wellness, and; healthy communities and social determinants of health, which provide a deeper dive into community engagement, social determinants of health and violence prevention. The identified priorities and associated data were subsequently presented to the WellSpan- Good Samaritan Hospital Board for their adoption. Board members discussed the data and identified priorities within the context of existing staffing and financial resources, current and future entity initiatives, and community partnership opportunities to address systemic community change. The final CHNA report, along with the WellSpan Community Health Improvement Plan (CHIP) was presented in June 2019 to the Planning Committee, at which time correlations were observed between the CHNA, CHIP and the WellSpan 2025 Strategic Plan.

WellSpan-Good Samaritan Hospital maintains its support of Lebanon County's safety net of services that enables access to care among vulnerable populations through: enrolling financially-challenged community members in Healthy Community Network, a partnership between WellSpan Health, physicians and community partners to support prospective enrollment, the management and support of patients, and coordination of care; supporting the expansion of a diabetes support group offered by Lebanon Valley Volunteers in Medicine to meet the needs of the growing, Spanish-speaking population in Lebanon, and; the ongoing partnership between Lebanon Family Health Services and WellSpan Good Samaritan Hospital to utilize doctors from the hospital's Family Medicine Residency program to provide prenatal care for its low-income clients. Additionally, WellSpan Good Samaritan Hospital leadership selected Family First Health, a federally qualified health center with locations throughout central Pennsylvania, to provide primary care services at the WellSpan Dixon Foundation Health Center. The WellSpan Dixon Foundation Health Center opened in 2020 and has improved access to primary care, behavioral health and other health and social services in Lebanon County. WellSpan-Good Samaritan Hospital is an integral partner in the Community Health Council of Lebanon County and, as such, supports key Council initiatives such as the Lebanon County Tobacco Coalition, Lebanon County Teen Pregnancy and Support Network, and Lebanon County Suicide Task Force. WellSpan-Good Samaritan Hospital maintains its support of the full-time, Executive Director position by leveraging Community Partnership Grant funds to cover this expense. Additionally, the Council maintains alignment with the Better Together Coalition in Lebanon County and launched a mobile kitchen to provide hands-on cooking classes to residents, in partnership with The American Heart Association. Additional efforts focused on: an email and social medical platform to connect residents to local health and wellness events and services; educational initiatives that emphasize importance of advanced care planning and end of life care, and; tackling the issue of homelessness by supporting the Lebanon County Coalition to End Homelessness. Community Health in Lebanon County continues to unfold in the offering of nutrition and food insecurity related efforts like the WellSpan Mondays Market program, which partners to provide a convenient location for families using Farmers Market Nutrition Program and WIC vouchers to shop for healthful foods. WellSpan's Market Bucks program addresses food insecurity and increases the consumption of fruits and vegetables. Regionally, this program provided vouchers to 310 WellSpan patients with food insecurity challenges, which contributed \$31,620 to local farmers and growers. Market Bucks consistently boasts an astounding 86% redemption rate, in addition to demonstrating increase fruit and vegetable consumption for participants with medical challenges. The initiative was created in 2013 to address the growing issue of adult overweight/obesity and utilizes a core website (www.10poundthrowdown.com) to encourage team participation and to offer an online weight tracker, badges to encourage healthier choices, and diverse health education resources.
