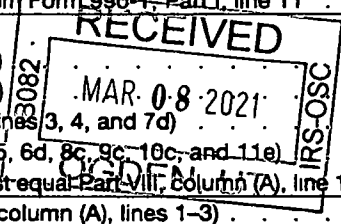

Ms. Page's powerful adaptation of Carmina Burana is set to composer, Carl Orff's, masterpiece of the same name about life, fortune and fate. This epic score is brought to life by the dancers as the wheel of fortune turns from joy to bitterness to hope and to grief. Our second work of Ms. Page's was titled Never Ending Road. This work is set to the strikingly beautiful music of Canadian born, Celtic Singer/Songwriter, Loreena McKennitt. The lead couple moves through a series of honeyed duets throughout the work and ends with a heartfelt pas de deux. We also presented an excerpt from Ms. Page's Colour Brillanté. A powerhouse of large ensemble work, Romanesque sets, and vivid attire, Colour Brillanté is a celebration of the many changing colors of fall. The fall series also showcased a repertoire piece choreographed by Tim Early, titled Visceral Form, that was performed by the Brandywine Contemporary dancers.
