Additional Supplemental Information	ADDITIONAL INFORMATION ON THE GRANTS IN PART II - PURPOSE Assistance League of Charlotte: To support its Mecklenburg County Teen Court program. The Teen Court program is an alternative justice system that offers youthful offenders ages 12-17 with no previous convictions an opportunity to avoid a permanent criminal record and take responsibility for their actions before a jury of their peers. Capital Area Immigrants' Rights: To support the Immigration Impact Lab which provides legal representation to asylum seekers in the Fourth Circuit Court. The Immigration Impact Lab litigates appeals and class actions lawsuits on behalf of asylum seekers & other noncitizens in the states within the Fourth Circuit, including the Carolinas, and beyond. Trainings and technical support are provided to private and non-profit immigration and criminal attorneys representing clients. Funding supports training local attorneys to handle asylum cases. Charlotte Center for Legal Advocacy: To support the pro bono program to provide legal services; to engage, train and support attorneys in pro bono opportunities; and to recognize the contributions of these attorneys. The program is dedicated to providing high-quality legal services to help underserved clients meet their most important needs for income, shelter, safety from violence, health care, education of children, fair treatment as consumers and equitable access to public and private benefits. International House of Metrolina: To expand the breadth of its start-up pro bono initiatives, enabling supervising attorneys to recruit and train pro bono attorneys, to evaluate cases for referral, and to mentor attorneys representing naturalization clients. The project benefits refugees, asylees and other underserved immigrants in Charlotte-Mecklenburg who qualify for naturalization. Funding supports professional development of staff attorneys through annual conferences, Continuing Legal Education courses and to support the Ginter Immigration Law Clinic. Pat's Place: To support a portion of the salary expense for a forensic interviewer and the expansion of the forensic interview program. Pats Place Child Advocacy Center coordinates the support and treatment of child survivors of the most serious cases of abuse in Charlotte and Mecklenburg County. The forensics interview is the foundation of child protection and criminal investigations. Safe Alliance: To help fund the salary of the Director of the Legal Representation Project (LRP). The LRP provides free legal representation in hearings to obtain Domestic Violence Protective Orders and acts as a conduit to allow local attorneys to donate their time to victims who need legal services. The Director is one of three staff positions (one being part-time) at LRP and is vital to fulfilling the agency's mission of representing domestic violence victims. Council for Children's Rights: To support the Council's Children's Defense Team as it relates to representing local juveniles. The Council's juvenile representation has expanded following North Carolina's Raise the Age legislation which now includes youths through age 17. InReach: To support InReach's education and training of Charlotte-Mecklenburg Police officers with how to interact with individuals with intellectual and developmental disabilities. Originally the grant award was to support Lunch and Learn sessions which offered these educational sessions. In November 2020 InReach requested that the grant award be reoriented to support disabled clients whose employment has been impacted by the pandemic. That request was approved by the MBF Board of Directors.
