In making such selections, the Board of Directors shall take into consideration the intent to have at least one representative on the Board, whether from the directors selected from Items 1-4 above or these additional directors, that have each of the following qualifications: a. Cultural Assistance Program ("CAP") representative who recruits and chairs a CAP Committee to interface with ECON, this corporation, and the community organizations with connections to children and their families which are proposed to and selected by the Board; b. Antiques & Garden Show ("AGS") board of directors member; and c. Representative with a finance and/or auditing expertise. Section 6.1 of the Bylaws is amended in its entirety to read as follows: Section 6.1. Number and Authority. The officers of the corporation shall be a President, who shall also act as Chairman of the Board of Directors, a secretary, and such other officers as determined by the Board of Directors.
