Share Inc. provides financial assistance on behalf of local residents who are in temporary financial difficulty. Payments are made directly to landlords, utility companies, medical service providers, and occasionally schools or automobile repair facilities. Payments are never made directly to clients. The great majority of payments are \$300 or less. For most payments in excess of \$1,000, 2 members of the Executive Committee must approve the payment. The exception to this is payments under the federal CARES Act, which are funded and vetted by the Fairfax County Coordinated Services Planning department. Such payments are also made directly to landlords or utility companies.

The financial assistance program is given an annual budget which is approved by Share's general membership. Prospective clients are vetted by Financial Assistance program volunteers, with the help of professional social workers employed by Fairfax County. Once a client is approved, a check request is made to the Share Treasurer, who sends the requested check.

All client information, check requests, and notes are maintained in both a Salesforce database and in a Quicken database used by the Treasurer.

Every month the two databases are reconciled to ensure that the correct payments have been made.

The budget is reviewed annually to ensure that total program payments are in accordance with the budget.
