When presented with a potential conflict, Board Officers work with the President and Counsel to investigate alternatives to the transaction. The Board Member involved with the potential conflict must recuse him or herself from discussions and decision-making surrounding the resolution of the conflict.

If it is determined that a more advantageous transaction cannot be obtained with reasonable efforts by the Association, then the Officers shall determine, with the approval of a majority of disinterested Directors, whether the transaction is in the Association's best interest and for its own benefit, whether the transaction is fair and reasonable to the Association, and whether to enter into the transaction. Minutes shall be taken to reflect the discussion of the conflict and Transaction, the nature of data reviewed, the record of votes taken, and any action the Officers agree to take on the conflict and transaction.
