VALLEY SCHOOL'S PRIMARY RESPONSIBILITY IS TO OUR CHILDREN. WE PRESENT A PROGRAM CENTERED ON THE CONCEPT OF THE CONTINUOUS GROWTH OF THE WHOLE INDIVIDUAL. BECAUSE OF OUR SCHOOL'S RELATIVELY SMALL SIZE, WE CAN RECOGNIZE INDIVIDUAL NEEDS AND DIFFERENT RATES OF GROWTH AND MATURATION, AND OPPORTUNITIES FOR SUCCESS CAN EXIST FOR EACH CHILD. WE MAKE A DELIBERATE EFFORT TO DEVELOP THE FOLLOWING HABITS: THE ABILITY TO THINK; THE SELF-DISCIPLINE TO WORK IN A CAREFUL, IMAGINATIVE, AND INDEPENDENT MANNER; A WILLINGNESS TO TRUST AND COOPERATE POSITIVELY WITH OTHERS; THE ABILITY TO RISK AND TO ADAPT TO NEW SITUATIONS.
