ADDITIONALLY, FOOD DONATIONS FROM INDIVIDUALS AND FOOD BANKS IN THE FLATHEAD VALLEY IS COLLECTED FOR DELIVERY TO BROWNING EVERY OTHER FRIDAY THROUGHOUT THE YEAR, THESE DELIVERIES STRATEGICALLY SUPPORT TWO KEY FOOD SECURITY PROJECTS FOR THE BLACKFEET NATION:- TO SUPPORT THE MEDICINE BEAR SHELTER WHICH SERVES DAILY MEALS TO THE HOMELESS POPULATIONS IN BROWNING AND PROVIDES FOOD BOXES TO COMMUNITY MEMBERS IN NEED. THE FOOD PRODUCTS DELIVERED TO THE SHELTER CONSIST OF NUTRITIOUS STAPLES INCLUDING FRUIT, VEGETABLES, DAIRY, EGGS, AND BREAD. WE ALSO WORK CLOSELY WITH FAST BLACKFEET (FOOD ACCESS SUSTAINABILITY TEAM), A BLACKFEET COMMUNITY NON-PROFIT, ESTABLISHING A FOOD RESOURCE CENTER AT THE MEDICINE BEAR SHELTER. THIS CENTER WILL OPERATE A FOOD PANTRY AND OPERATE A COMMERCIAL KITCHEN FOR NUTRITIONAL EDUCATION.
