(THE FOUNDATION) ASSUMED ALL OF EXCEL ACADEMY BREMEN STREET REALTY CORPORATION'S (BSRC'S) ASSETS AND LIABILITIES, INCLUDING THE INTERCOMPANY NOTES PAYABLE TO THE EXCEL ACADEMY CHARTER SCHOOL (SCHOOL). THE SCHOOL FORGAVE THESE INTERCOMPANY NOTES PAYABLE IN EXCHANGE FOR THE FOUNDATION ASSUMING THE SCHOOL'S REVENUE BONDS AND ANOTHER NOTE PAYABLE. THE FOUNDATION ALSO PROVIDED APPROXIMATELY \$3.6 MILLION TO THE SCHOOL FROM THE PROCEEDS OF THE SERIES 2019 REVENUE BONDS, WHICH THE SCHOOL USED TO PAY OFF A DIFFERENT NOTE PAYABLE. BSRC AUTHORIZED A DEED TRANSFER OF THE HIGH SCHOOL PROPERTY TO THE FOUNDATION AND ASSIGNED ITS CAPITAL LEASE WITH THE SCHOOL TO THE FOUNDATION. THE FOUNDATION THEN PROVIDED A MORTGAGE INTEREST ON THE HIGH SCHOOL PROPERTY TO THE FINANCIAL INSTITUTION WHICH IS THE TRUSTEE OF ITS BONDS PAYABLE. THE SCHOOL AND THE FOUNDATION ALSO FORGAVE A PORTION OF THE DUE FROM BSRC AT OCTOBER 31, 2019. THE REMAINING APPROXIMATELY \$917,000 OF ACCRUED RENT RECEIVABLE FROM THE SCHOOL RELATING TO THE CAPITAL LEASE WAS ASSIGNED TO THE FOUNDATION AND PAID BY THE SCHOOL IN FISCAL YEAR 2020. BSRC WAS DISSOLVED IN FISCAL YEAR 2020.
