THE ORGANIZATION DIRECTS FUNDRAISING FOR PRIVATE GIFTS, MANAGES THE ENDOWMENT AND ASSISTS WITH THE ACQUISITION OF ARTIFACTS FOR THE COLLECTION OF THE JAMESTOWN SETTLEMENT AND YORKTOWN VICTORY CENTER MUSEUMS. THE ORGANIZATION RECEIVES CHARITABLE GIFTS AND DONATIONS FOR THE BENEFIT OF THE FOUNDATION.

JAMESTOWN SETTLEMENT RENEWAL - TO ENSURE A CONTINUED EXCELLENT VISITOR EXPERIENCE, A LARGE-SCALE, PHASED RENOVATION TO JAMESTOWN SETTLEMENT'S PERMANENT GALLERIES WAS LAUNCHED IN 2016 AND CONCLUDED DURING THE 2020 FISCAL YEAR. JAMESTOWN SETTLEMENT'S RENEWED GALLERY EXPANDED ON HISTORICAL EVENTS MARKING 400-YEAR MILESTONES, SUCH AS THE FIRST LEGISLATIVE ASSEMBLY IN THE NEW WORLD, THE FIRST RECORDED AFRICANS IN VIRGINIA, AND THE ARRIVAL OF ENGLISH WOMEN TO THE VIRGINIA COLONY. NEW HISTORICAL RESEARCH AND TECHNOLOGY, INCLUDING INTERACTIVE TOUCH SCREENS, IMMERSIVE EXHIBITS AND A MULTIMEDIA EXPERIENTIAL THEATER, ENHANCED THE STORY OF THE VIRGINIA INDIANS WITH NEW RESEARCH ON POWHATAN'S CAPITAL AT WEROWOCOMOCO AND POCAHONTAS, AS WELL AS THE FIRST RECORDED AFRICANS IN 1619 AND THE GROWTH IN SLAVERY THROUGH 1699. THE RENOVATION INCLUDED A 124-SEAT REBELLION THEATER, WHERE THE STORY OF "BACON'S REBELLION" UNFOLDS ON MULTIMEDIA SCREENS WITH SPECIAL EFFECTS. THESE CHANGES PLAY AN IMPORTANT ROLE IN THE ENSUING DECADE, EXPANDING AND UPDATING THE JAMESTOWN STORY TO HONOR THE RICH CULTURAL HERITAGE OF THE POWHATAN INDIANS, EUROPEANS, AND WEST CENTRAL AFRICANS. 2019 COMMEMORATION, AMERICAN EVOLUTION THE 2019 COMMEMORATION, AMERICAN EVOLUTION HIGHLIGHTED EVENTS THAT OCCURRED IN VIRGINIA IN 1619 THAT CONTINUE TO INFLUENCE AMERICAN TODAY, COMMEMORATING THE ONGOING JOURNEY TOWARD THE KEY IDEALS OF DEMOCRACY, DIVERSITY, AND OPPORTUNITY, AND CONCLUDED IN DECEMBER 2019. LEADERSHIP THE JAMESTOWN-YORKTOWN FOUNDATION BOARD OF TRUSTEES APPOINTED CHRISTY S. COLEMAN AS THE NEW EXECUTIVE DIRECTION OF THE FOUNDATION IN LATE DECEMBER 2019; SHE BEGAN SERVING IN THE POSITION ON JANUARY 21, 2020. SHE SUCCEEDS PHILIP G. EMERSON, WHO RETIRED IN DECEMBER 2019 AFTER 33 YEARS OF SERVICE IN SHAPING JAMESTOWN SETTLEMENT AND THE AMERICAN REVOLUTION MUSEUM AT YORKTOWN INTO WORLD-CLASS MUSEUMS AND A LEADER IN EDUCATION. AS THE THIRD EXECUTIVE DIRECTOR IN THE AGENCY'S 62-YEAR HISTORY, EMERSON WAS HONORED WITH A SPECIAL RESOLUTION DESIGNATING HIM "EXECUTIVE DIRECTOR EMERITUS AND NAMING THE CENTRAL SUPPORT COMPLEX AFTER HIM. COLEMAN, FORMER CEO OF THE AMERICAN CIVIL WAR MUSEUM, IS A NATIONALLY RECOGNIZED AUTHORITY ON THE CULTURAL AND EDUCATIONAL IMPORTANCE OF MUSEUMS AND HISTORICAL PLACES FOR DIVERSE NATIONAL AND INTERNATIONAL AUDIENCES. COVID-19 ON MARCH 14, 2020, THE JAMESTOWN-YORKTOWN FOUNDATION MUSEUMS AND ITS CENTRAL SUPPORT FACILITY CLOSED TO THE PUBLIC AND STAFF, FOLLOWING AN ORDER BY GOVERNOR NORTHAM TO CLOSE ALL STATE FACILITIES ON THE HAMPTON ROADS PENINSULA IN RESPONSE TO THE COVID-19 PANDEMIC. THE FOUNDATION'S MUSEUMS RE-OPENED TO THE PUBLIC ON JUNE 24, 2020, WITH EXTENSIVE SAFETY PROTOCOLS IN PLACE. ANNUAL FUND IN FISCAL YEAR 2020, THE ANNUAL FUND RAISED \$879,846 IN CASH AND IN-KIND GIFTS. GIFTS TO THE ANNUAL FUND PROVIDE UNRESTRICTED SUPPORT THAT HELPS SUSTAIN THE FOUNDATION'S MUSEUMS AND EDUCATION PROGRAMS, INCLUDING ARTIFACT ACQUISITION, LIVING-HISTORY INTERPRETATION WITHIN THE OUTDOOR EXHIBITS, FIELD TRIPS, AND CLASSROOM OUTREACH FURTHERING THE FOUNDATION'S EDUCATIONAL MISSION. ENDOWMENT THE JAMESTOWN-YORKTOWN FOUNDATION, INC. HAS INVESTMENT OVERSIGHT OVER ALL OF THE FOUNDATION'S ENDOWED ASSETS, WHICH AS OF JUNE 30, 2020 AMOUNTED TO \$19.3 MILLION. FOR THE FISCAL YEAR 2020, THE ENDOWMENTS' EXPENDABLE EARNINGS WERE USED TO SUPPORT CORE PUBLIC AND STRUCTURED EDUCATION PROGRAM AREAS INCLUDING INTERPRETATION, MARITIME EDUCATION, OUTREACH EDUCATION, SPECIAL EXHIBITIONS, AND ARTIFACT ACQUISITION.

"TENACITY" WAS A LEGACY PROJECT OF THE 2019 COMMEMORATION, AMERICAN EVOLUTION. THE "18TH NATIONAL EXHIBITION OF THE AMERICAN SOCIETY OF MARINE ARTISTS" WELCOMED VISITORS BEGINNING ON MARCH 7, 2019. THE NATION'S OLDEST AND LARGEST NONPROFIT ORGANIZATION DEDICATED TO MARINE ART AND HISTORY PARTNERED WITH THE JAMESTOWN-YORKTOWN FOUNDATION TO PRESENT A SPECIAL EXHIBITION FEATURING 110 WORKS OF MARINE ART, INCLUDING PAINTINGS, SCULPTURES, AND SCRIMSHAW CARVINGS. THE SHOW HIGHLIGHTS THE WORKS OF ARTISTS REPRESENTING THE BEST IN AMERICAN MARINE ART BY JURIED COMPETITION. AT THE AMERICAN REVOLUTION MUSEUM AT YORKTOWN, THE SPECIAL EXHIBITION "FORGOTTEN SOLDIER" BEGAN WELCOMING VISITORS ON JUNE 29, 2019 TO DISCOVER THE PERSONAL STORIES OF ENSLAVED AND FREE AFRICAN AMERICANS WHO FOUGHT ON BOTH SIDES OF THE REVOLUTIONARY WAR. THE EXHIBITION, EXTENDED THROUGH JULY 8, 2020, FEATURED TWO RARE DOCUMENTS ON DISPLAY TOGETHER FOR THE FIRST TIME SINCE 1783, THE "BOOK OF NEGROES" ON LOAN FROM THE NATIONAL ARCHIVES, U.K., AND THE "INSPECTION ROLL OF NEGROES BOOK NO. 1," ON LOAN FROM THE U.S. NATIONAL ARCHIVES. "FORGOTTEN SOLDIER" SHOWCASED AN ORIGINAL COMMISSIONED ARTWORK BY TITUS KAPHAR, AN AMERICAN CONTEMPORARY ARTIST AND 2018 MCARTHUR FELLOW WHOSE WORK INVITED VISITORS TO LOOK AT HISTORY IN A NEW LIGHT. THE EXHIBITION WAS COMPLEMENTED BY A SERIES OF PUBLIC PROGRAMS, INCLUDING A FAMILY HISTORY WORKSHOP SERIES, PANEL DISCUSSION, AND "THE AFRICAN AMERICAN SOLDIER" SPECIAL EVENT. EVENTS INCLUDED "LIBERTY CELEBRATION," "AMERICAN INDIAN INTERTRIBAL POWWOW," "YORKTOWN VICTORY CELEBRATION," "FAMILY FRIGHTS AT JAMESTOWN SETTLEMENT," "THE AFRICAN AMERICAN SOLDIER," "FOODS & FEASTS OF COLONIAL VIRGINIA," "CHRISTMASTIDE IN VIRGINIA," "AFRICAN-AMERICAN CULTURAL HERITAGE MONTH," "AFTER ANGELO: CELEBRATING BLACK WOMEN IN AMERICA, AND A LECTURE SERIES AT JAMESTOWN SETTLEMENT THAT EXPLORED THEMES FROM THE SPECIAL EXHIBITION "TENACITY: WOMEN IN JAMESTOWN AND EARLY VIRGINIA."
