

In addition, these donations provide the resources needed to support programs and materials such as Playground Partners/Equipment, SOAR/Buddy Benches, Curriculum Enhancement Materials, Science Equipment and Supplies, Art Studios (Supplies and Curriculum), Garden Science Nutrition Kitchen and Supplies, and many other Teacher/Classroom needs as requested. Each school site/chapter creates fundraising events to support the needs of their site. The Fall Pledge Drive or Annual Giving Fund Drive, Spring Galas and Auctions, Carnivals, Pancake Breakfasts, Bowl/Read/Jog a Thons, etc are examples of events at each school site used to raise donations to support the programs at their sites deemed needed per the site councils. ALL ON CAMPUS EVENTS and LIVE ON CAMPUS TEACHING WAS CEASED ON MARCH 13, 2020 SO MANY OF THE FUNDRAISING EVENTS DID NOT OCCUR FOR THIS TAX/SCHOOL YEAR.
