ALTHOUGH CONTRIBUTING MEMBERS WILL HAVE NO VOTING RIGHTS, THEY MAY PROVIDE INPUT TO THE BOARD OF TRUSTEES OF THE ORGANIZATION AS TO (I) AREAS OF NEED IN SAN DIEGO COUNTY AND ITS NEIGHBORING COMMUNITIES AND (II) APPROPRIATE CHARITABLE RECIPIENTS OF GRANTS AND GIFTS FROM THE ORGANIZATION. IN THIS WAY, THE ORGANIZATION WILL INTRODUCE WOMEN IN SAN DIEGO COUNTY TO PHILANTHROPY AND CULTIVATE THEIR ABILITY TO PARTICIPATE IN ALL PARTS OF THE CHARITABLE GIVING PROCESS. THE ASSETS OF THE SAN DIEGO WOMEN'S FOUNDATION ARE HELD AT THE SAN DIEGO FOUNDATION, THE SUPPORTED ORGANIZATION. AS OF JUNE 30, 2020, THE VALUE OF THESE ASSETS WAS \$4,290,855. THE PRIMARY GRANTING PRIORITY FOR FISCAL YEAR 2020 WAS BASIC NEEDS & TRANSITION SERVICES FOR ASYLEES & ASYLUM SEEKERS. A TOTAL OF \$311,528 WAS GRANTED TO 7 COMMUNITY PARTNERSHIP GRANTEEES (NON-PROFITS). IN ADDITION, THE SAN DIEGO WOMEN'S FOUNDATION GRANTED \$30,000 TO THE SAN DIEGO FOUNDATION IN SUPPORT OF THE COVID RELIEF EFFORT. THESE FUNDS WERE GRANTED BY THE SAN DIEGO FOUNDATION TO NON-PROFITS ADDRESSING THE COMMUNITY NEEDS DUE TO THE PANDEMIC. SINCE ITS FOUNDING IN 2000, THE SAN DIEGO WOMEN'S FOUNDATION HAS GRANTED OVER \$4 MILLION TO 109 COMMUNITY PARTNER PROGRAMS AND BUILT AN ENDOWMENT OF \$3.8 MILLION.
