4a (Code: ) (Expenses \$ 123,815 including grants of \$ ) (Revenue \$ ) Ignatian Family Teach-In For Justice: In November 2019, nearly 2,000 individuals from more than 150 institutions across the Jesuit and broader Catholic network gathered in Arlington, Virginia, and Washington, D.C. for the 21st annual Ignatian Family Teach-In for Justice and Advocacy Day. The weekend empowered leaders, illustrating how each person and their sphere of influence can build momentum toward justice and hope, from the very personal to the global. Teach-in attendees represented over 30 U.S. states, Canada, El Salvador, and Mexico, including over seventy Jesuit universities, high schools, and parishes. Not only did attendees grow in their knowledge of a wide range of social justice issues facing society today, but they also had the opportunity to deepen their faith life through prayer and reflection, network with peers and colleagues from throughout the hemisphere, and take action as legislative advocates. On the Monday following the Teach-In, more than 1,500 of the attendees met with over 125 Congressional offices to discuss (continued on Schedule O).

4b (Code: ) (Expenses \$ 188,834 including grants of \$ ) (Revenue \$ ) Marketing - Ignatian Solidarity Network digital engagement grew significantly in FY2019-2020. Over 320,000 unique users visited ignatiansolidarity.net during the 12-month period, a 90% increase from the previous year. In March, as the world came to an abrupt halt due to COVID-19 shutdowns, ISN quickly responded, publishing a series of Ignatian Examens, a dynamic resource page, and broadcasting live events with partners responding to immediate needs in their communities - all to equip the network to grapple with the dramatic shift in life, and the inequities in our society laid bare by the pandemic. ISN's website, ignatiansolidarity.net became a hub for many of these resources. Education for Justice, acquired by Ignatian Solidarity Network in January, 2019, has become a core element of ISN's resource offerings as well. As of June, 2020, nearly 1,000 Catholic educators and ministers are active members of Education for Justice through over 500 individual and institutional memberships. (continued on Schedule O).

4c (Code: ) (Expenses \$ 175,431 including grants of \$ ) (Revenue \$ ) Migration Programming - ISN continued to build our network of immigration advocates, addressing issues including the right to seek asylum, border policy, support for DACA recipients and undocumented members of the Ignatian family, and issues surrounding immigration detention, particularly that of families and children. In July of 2019, 32 from 14 Jesuit universities, gathered on John Carroll University's campus for the annual Ignatian Justice Summit (IJS). The Summit focused on the timely immigration through an Ignatian lens - with programming preparing students to organize and lead immigration advocacy efforts on their campuses. At the Ignatian Justice Summit, students heard from dynamic speakers and panels focused on Ignatian spirituality and pedagogy, campus organizing, immigration policy, advocacy best practices, and personal migration stories. of migration included the first-ever Jesuit Parish Advocacy, held virtually in June 2020.

Thirty-five participants engaged in immigration advocacy meetings with six Congressional

offices, including one all-Spanish-speaking delegation and meeting.

the Jesuits' new Universal Apostolic Preferences, exploring how the preferences can be woven into parish life. Multiple pathways toward this goal were provided, including opportunities for more deeply exploring the context and history of the preferences, reflection, best-practice sharing, networking, and action planning. The Summit concluded with parish action planning. Each parish delegation was asked to determine one to three actions that would enhance and deepen their parish's justice work. Action plans presented ranged from increased spiritual care for those already engaged in justice work to ethical coffee purchasing and utilizing the liturgical calendar to building awareness, solidarity, and action around specific issues. The 2019-2020 Solidarity on Tap season started strong, with thirteen events held in nine cities across the U.S. from July 2019 through early March 2020. In March, ISN quickly pivoted as pandemic shutdowns spread across the U.S. to bring twelve virtual Solidarity on Tap gatherings live to the Ignatian network, with speakers including Fr. Greg Boyle, S.J., Cecilia Gonzelez-Andrieu, Ph.D., Marcia Chatelain, Ph.D., Sr. Simone Campbell, S.S.S., Olga Segura, and Sr. Helen Prejean, C.S.J. In the wake of the killings of black individuals by law enforcement, including Breonna Taylor and George Floyd, ISN developed a number of initiatives and campaigns to respond to the needs of our network related to racial justice. In June, we hosted a Virtual Prayer Vigil for Lamentation and Racial Justice, attended by over 350 live viewers, during which the lives of Taylor, Floyd, and other black Americans killed by law enforcement personnel were commemorated. That same week, ISN published a 21-Day Racial Equity Challenge that can be received daily via e-mail or accessed online and a Novena for Racial Justice, which is available in English and Spanish as well as in an audio format in English. Nearly 3,000 people have utilized the racial equity challenge and a number of high schools and universities will be accessing it during the school year to engage their students, faculty, staff and parents. Ecological justice also became a growing part of the Ignatian Solidarity Network's efforts in 2019-2020. The 2020 Lenten Food Waste Fast invited the Ignatian family to "give up" food waste for Lent. Over 1,800 individuals committed to learn, pray, and act on the issue of food waste as nearly 40% of the food grown in the United States is never eaten. Weekly challenges included food storage tips, pantry organization,

learning how to use leftover scraps in creative ways, and composting. Additionally, in partnership with EarthBeat, a project for National Catholic Reporter, around 10,000 individuals were invited to read daily prayerful reflections on food, faith, and climate related to the Food Waste Fast.
