THE MUSEUM WAS REQUIRED BY THE STATE OF OHIO TO CLOSE FROM MID-MARCH THROUGH MID-JUNE, DURING WHICH TIME REVENUE DROPPED 30%. THANKFULLY, IN APRIL 2020 THE MUSEUM WAS ABLE TO SECURE A \$1.8M LOAN THROUGH THE PAYCHECK PROTECTION PROGRAM OFFERED BY THE SMALL BUSINESS ADMINISTRATION. THE PPP LOAN, WHICH WAS FULLY FORGIVEN IN DECEMBER 2020, ALLOWED THE MUSEUM TO MAINTAIN FULL EMPLOYMENT THROUGH JUNE 30, 2020. WHILE WORKING FROM HOME, THE STAFF WAS ABLE TO DEVELOP ALTERNATIVE VIRTUAL PROGRAMMING, WHICH WAS IMPLEMENTED DURING THE CLOSURE AND CONTINUES TODAY. ALTHOUGH IN PERSON CLASSES WERE CANCELLED, WHEN THE MUSEUM REOPENED IN JUNE, MODIFIED CLASSES AND ACTIVITIES WERE HELD OUTDOORS ON THE MUSEUM CAMPUS AND THE GALLERIES WERE REOPENED TO THE PUBLIC. THE EFFORT TO TRANSITION PROGRAMMING AND TO MODIFY THE FACILITIES TO MEET THE EVER CHANGING COVID RESTRICTIONS REQUIRED PARTICIPATION FROM ALL AREAS IN THE MUSEUM. THIS WAS ONLY POSSIBLE THROUGH THE HARD WORK OF MUSEUM STAFF AND THE CONSISTENT SUPPORT AND STRONG LEADERSHIP OF JOHN STANLEY, OUTGOING INTERIM DIRECTOR AND ADAM LEVINE, CURRENT DIRECTOR. THROUGH A DILIGENT AND CONTINUOUS EFFORT TO PROVIDE A SAFE ENVIRONMENT FOR ALL, THE TOLEDO MUSEUM OF ART HAS REMAINED OPEN TO THE COMMUNITY SINCE REOPENING ON JUNE 23, 2020.
