ARTS IN THE PARKS - THIS POPULAR PROGRAM WAS LAUNCHED IN 1977 AND CONTINUES TO PROVIDE ACCESS TO THE ARTS FOR CHILDREN DURING THE SUMMER MONTHS. OVER 15,000 CHILDREN HAVE PARTICIPATED IN THE PROGRAM SINCE ITS INCEPTION. THE WORKSHOPS ARE DESIGNED FOR CHILDREN AGES SIX THROUGH TWELVE AND PROVIDE INTENSIVE INTRODUCTIONS TO SPECIFIC ART-FORM MEDIUMS. WORKSHOPS ARE TYPICALLY LED BY PROFESSIONAL ARTISTS AND ARTS EDUCATORS, WHO ARE REFERRED TO AS TEACHING ARTISTS. IN JULY 2019 THE PROGRAM INCLUDED THIRTEEN COMMUNITIES IN FIVE COUNTIES IN INDIANA AND OHIO. DUE TO THE COVID-19 PANDEMIC, THE ANNUAL FESTIVAL AT ARTS PARK (A PART OF THE ARTS IN THE PARKS PROGRAM) WAS CANCELLED. AS WELL, THE CLASSES, WHICH CONSTITUTE THE MOST SIGNIFICANT COSTS FOR THE PROGRAM AND NORMALLY BEGIN IN EARLY JUNE, WERE POSTPONED UNTIL EARLY JULY. RESTRICTED FUNDS SECURED FOR THE SUMMER 2020 PROGRAM WERE ROLLED OVER TO COVER COSTS IN JULY AND AUGUST OF 2020. CLASSES WERE ORGANIZED FOR SMALLER CLASS SIZES, WITH SOCIAL DISTANCING, MASKS, AND SIGNIFICANT HYGIENE PROTOCOLS FOR STUDENTS AND TEACHING ARTISTS REQUIRED. REGISTRATION FOR THE PROGRAM BEGAN IN LATE JUNE 2020. DUE TO THE PANDEMIC, LEADERSHIP DECIDED TO OFFER THE PROGRAM FREE OF CHARGE FOR THE SUMMER OF 2020 (CLASSES NORMALLY COST \$5.00 PER CLASS OFFERING TO A MAXIMUM TUITION OF \$30.00). ARTWORKS - THIS PROGRAM PROVIDES INSTRUCTION IN THE VISUAL ARTS. CLASS OFFERINGS, FOR BOTH CHILDREN AND ADULTS, INCLUDED DRAWING, PRINTMAKING, CERAMIC HAND BUILDING, WEAVING, JEWELRY MAKING, WATERCOLORS, ALCOHOL INKS, RESIN CASTING, TIE DYING, SCULPTURE, MASK-MAKING, PHOTO ENCAUSTICS, NEEDLE FELTING, QUILTING, OIL PAINTING, CERAMIC TILES, CERAMIC WHEEL THROWING, AND BASKET WEAVING. INSTRUCTION WAS PROVIDED AT ALL THREE OF THE ARTS PLACE CENTERS. IN MID-MARCH ALL ARTWORKS CLASSES WERE CANCELLED DUE TO THE COVID-19 PANDEMIC. A SCHEDULE FOR THE FALL OF 2020 IS BEING PLANNED WITH SMALLER CLASS SIZE MAXIMUM ENROLLMENTS TO ALLOW FOR SOCIAL DISTANCING AND OTHER SAFETY PROTOCOLS. EXHIBITS - THIS PROGRAM IS CONDUCTED AT ALL THREE ARTS PLACE CENTERS. EXHIBITS AT THE PORTLAND CENTER ARE PRESENTED IN THE HUGH N. RONALD GALLERY, AND TWO SMALLER GALLERIES, PROVIDING A HIGHLY FLEXIBLE EXHIBITION SPACE. IN 2019-2020, A NUMBER OF ONE AND TWO-PERSON SHOWS WERE PRESENTED, INCLUDING EXHIBITS BY TORI TASCH, ERIN ELIZABETH AND HENRY SIDEBOTHAM, AND JONPAUL SMITH. GROUP EXHIBITIONS INCLUDED UNSTRUCTURED STRUCTURE FEATURING KATHY HIRSH, ANN PRIMACK, SUE NADIS, AND JILL KEMER, THE INDIANA ARTISAN FURNITURE GUILD, AND THE ALCOVE. THE ANNUAL REGIONAL STUDENT ART EXHIBITION WAS ONCE AGAIN PRESENTED AT THE PORTLAND CENTER. THE EXHIBIT FEATURED THE WORK OF PRIMARY AND SECONDARY SCHOOL STUDENTS FROM THE SERVICE AREA. AS THE EXHIBIT COULD NOT OPEN IN LATE MARCH DUE TO THE PANDEMIC, ARTS PLACE PHOTOGRAPHED EVERY WORK IN THE EXHIBIT FOR DISPLAY ON ARTS PLACE'S WEBSITE AND ALSO THROUGH FACEBOOK. WHEN ARTS PLACE WAS ABLE TO REOPEN TO THE PUBLIC IN MID-JUNE THE EXHIBIT WAS EXTENDED TO THE END OF THE FISCAL YEAR. THE ANNUAL STITCH N' CHATTER QUILT SHOW WAS ALSO HOSTED AT THE PORTLAND CENTER IN AUGUST 2019. A FULL SCHEDULE OF EXHIBITS WAS PRESENTED AT BOTH THE AUGLAIZE/MERCER CENTER AND THE BLACKFORD COUNTY ARTS CENTER. THE AUGLAIZE/MERCER CENTER'S THIRD JURIED ART EXHIBIT WAS OFFERED IN THE LATE SUMMER OF 2019. THE BLACKFORD COUNTY ARTS CENTER CONDUCTED ITS SIXTH JURIED ART SHOW IN JULY 2019. EXHIBITS AT THE BLACKFORD CENTER ALSO INCLUDED A GROUP SHOW BY THE ALCOVE. THE AUGLAIZE/MERCER CENTER AND THE BLACKFORD COUNTY ARTS CENTER WERE BOTH CLOSED TO THE PUBLIC FROM MID-MARCH TO MID-JUNE 2020 DUE TO THE PANDEMIC. PUBLIC INFORMATION SERVICES - ARTS PLACE PROVIDED ARTS INFORMATION SERVICES ON ARTISTS, ARTS EVENTS, AND ARTS ORGANIZATIONS IN BOTH THE SERVICE AREA AND WELL BEYOND. WEB SERVICES AND SOCIAL MEDIA WERE THE PRIMARY TOOLS FOR PROVIDING THIS INFORMATION. THE CORPORATION ALSO PUBLISHES AN ONLINE NEWSLETTER. THE WEBSITE ARTSLAND.ORG PROVIDES UP-TO-DATE INFORMATION ON ARTS EVENTS AND SERVICES PRESENTED OR HOSTED BY ARTS PLACE.
