Educational: The Maryville Jen School (grades 7 to 12) serves children from the community with complex emotional, behavioral and learning disabilities. The school staff uses hands-on, alternative and experiential teaching methods in conjunction with traditional instruction methods to maximize the students' potential for success. The teaching staff coordinates with our therapeutic staff to ensure that our students make advancements. During FY2020, Maryville's Jen School program provided educational services to 85 youth. Specialized Programs: The Maryville Crisis Nursery is for families with children 0-6 years of age who are experiencing some type of crisis and need emergency child care for up to 72 hours. Maryville Academy's Community Outreach programs include a golf program which teaches life lessons by providing basic golf skills and golf-related vocational training to children and adolescents through age twenty. Maryville also runs a Catholic Youth Organization (CYO) which offers athletic programs for junior high and high school age youths living in the Chicago metropolitan area, focusing on economically disadvantaged communities within that area.
