The Foundation raises funds to give to the Hospital which uses the money to help cover operating costs associated with delivering patient care. In the Fiscal Year 2020, the Foundation raised funds through the Trip of the Month project and the Golf Tournament. These funds were used to fund Nursing Scholarships to help promote healthcare workers. Fiscal Year 2020 is the last year of the Golf Tournament. The Foundation continues to administer the Serving of Hope funds from monies raised in prior years. They take the applications and disburse funds to individuals in need of travel assistance for serious medical conditions. The amount of money distributed in FY 2020 was \$19,009 to 46 individuals. In addition to that fund, the Foundation also manages the Havre Women's Golf Association Assistance Fund. For the 2020 year \$11,750 was distributed to 22 individuals. The Foundation administers two awards for employees at Northern Montana Care Center: The Wally Schmockel Award and the Max Kuhr Memorial Award.
