FMC is a sole community provider of healthcare services in rural Fallon County, Montana. It is predominantly a primary care provider for its service area, consisting of a number of entities structured under a charitable non-profit corporation. It strives to excel at offering family practice and preventative health outpatient services, routine hospital, lab and fully digital diagnostic services, 24-hour emergency care, intermediate swing bed long-term care, home-based skilled and personal care, and physical and occupational therapy. Fallon Medical Complex (FMC) provides quality health care regardless of race, creed, sex, national origin, handicap, age, or ability to pay. Although reimbursement for services rendered is critical to the operation of FMC, it is recognized that not all individuals possess the ability to purchase these essential services. It is FMC's mission to serve the surrounding area by providing health care services to all community members. FMC provides medical services to individuals who are determined unable to purchase such services through FMC's Financial Assistance policy and guidelines. In addition to free and/or subsidized care, services are also provided at below cost rates to persons covered by government programs. Recognizing its mission to the community, services are provided to both Medicare and Medicaid patients. The unreimbursed value of providing care to these patients, based on established rates is \$31,000 for the year ended June 30, 2020. FMC's Critical Access Hospital provides 24 hour x 7 days a week Emergency Room services, observation, Acute Care, Swing Bed services and onsite ancillary lab and diagnostic imaging services. During fiscal year ended June 30, 2020, FMC provided over 306 days of hospital services, 5,959 days of swing bed care, 949 ER visits, and over 7,800 outpatient visits.

To this end, not only does the organization routinely budget \$30,000 or more in continuing education for its employees, it also provides job shadowing to area students (typically 3-5 students per year) who may be interested in a healthcare career, in addition to offering routine Certified Nursing Assistant training programs (to about 5-10 prospective aides per year). FMC also hosts numerous college students seeking careers as doctors (1-2 per year), physician assistants (1-2 per year), and various other disciplines, such as nursing, radiology & laboratory technology and physical therapy. FMC further believes that it is its responsibility to take a leadership role in informing the public about healthcare subjects of relevance or interest through community education. This objective is supported through a number of channels, which includes routine "Lunch and Learn" sessions provided by medical professionals (about 6 times per year), weekly public service announcements on the local radio station, and an annual health fair which is attended by people from all over the service area.

Part II, Community Building Activities:	<p>FMC participates in a number of community building activities to improve our community. Our Foundation Coordinator has been a member of the local housing board, searching for ways to address our community's chronic housing shortage by facilitating the construction of new housing and the renovation of existing housing. In addition, FMC manages a senior independent living complex for Fallon County. Although the county does reimburse direct expenses for maintenance, one of our employees acts as a "property manager," coordinating tenant turnover, fielding questions or concerns, calling for property services, etc. From an economic development standpoint, our Foundation Director has also been a board member of our local Southeastern Montana Revitalization Team (SMART) which is dedicated to revitalizing the economic climate in the area. They are focused on building community infrastructure, as well as attracting new businesses and finding ways to provide housing for incoming workers and their families. In addition, our Foundation Director is a board member on the Eastern Montana Economic Development Authority (EMEDA), which has been actively pursuing the creation of a licensed child daycare, none of which currently exist in Fallon County. Lastly, to help keep local commerce alive, our Foundation Coordinator is Treasurer for the Baker Chamber of Commerce, actively participating in meetings and events, including hosting their monthly meeting on a rotating basis. One of the Chamber's primary events, the Fall Festival, is coordinated by FMC staff, who also participate in the Chili Cook-off event every year. To further support the community, several FMC employees frequently participate in disaster preparedness meetings and events through the Fallon County Local Emergency Preparedness Committee (LEPC). This group meets regularly to discuss disaster preparedness activities, to review the response of similar groups to disasters across the nation, to determine ways to enhance the effectiveness of disaster response in our area and to conduct tabletop exercises that simulate potential local disasters. We have also dedicated staff time and resources to acquiring knowledge in the Hospital Emergency Incident Command System (HEICS), a nationally recognized program in incident management. Since the advent of the Covid-19 pandemic, we have actively participated in local, state, and federal initiatives to curb its spread and to keep our community as safe as possible. Through years of training in disaster preparedness, we had developed the necessary organizational tools and ramped up an adequate (initial) supply of PPE to weather the storm. Collaboratively, we distributed PPE to public health, law enforcement, EMS, and fire control officials until their own supplies could be built up. Our CEO is a licensed Landscape Architect with a strong interest in improving and maintaining our environment. He plans, installs, and maintains the grounds surrounding our facility, to ensure its long-term viability and meaningful contribution towards the effective healing of our patients. Our CEO also participates in community initiatives regarding environmental improvements when asked. In an effort to assist with leadership development, two staff members routinely provide assistance with youth leadership programs. For instance, one of our Physical Therapists has acted as a 4H leader for several years, participating in youth developmental programs that provide hands-on learning activities to youth. In addition, our CEO provides coaching and judging for our local Business Professionals of America (BPA) chapter, which teaches basic and advanced business skills to high school students. Our CEO has also acted as a judge for local Speech and Drama events, which helps high school students gain valuable skills in public speaking and performing. FMC participates in coalition building by contributing to collaborative efforts that address health and safety issues, including LEPC and HEICS mentioned earlier, with other healthcare entities and emergency service providers. Our CEO is also a board member on a frontier facilities initiative sponsored by the Montana Health Network (MHN). This group strives to find collaborative programs that benefit small rural hospitals patients through increased access to services. For instance, the hospitals have collaborated in a HRSA grant has been funding a chronic care consortium to more closely monitor patients with chronic conditions and to proactively attend to their needs. The overall goal is to address their health issues on a more consistent and timely basis, thereby increasing their health status while decreasing the cost of care. Lastly, we collaborate with Holy Rosary Healthcare in Miles City, MT to offer a medically guided wellness program called "Healthy Lifestyles" which focuses on nutrition, exercise and mental wellbeing. The purpose of the program is to help participants make long-term, sustainable changes to live a</p>

Part II, Community Building Activities:	<p>more healthful life. Participants receive 1:1 personal coaching as well as regular group education sessions via telemedicine. One of our larger efforts to assist with community health improvement is to take an active role in offering, serving and significantly subsidizing noon meals to seniors. FMC collaborates with our local Council on Aging to serve 1,788 meals each year to seniors in our facility dining room as well as an additional 2,501 meals through Meals on Wheels. This program promotes health and well-being of our seniors by providing nutritious meals to those who might otherwise not receive them, especially those who are home bound. FMC's workforce development support is largely focused on healthcare careers. We annually work with the local school system to offer "Medical Explorers," which allows students to ask medical professionals questions about their job and learn about the myriad of healthcare careers. Some years we are able to secure a patient simulator to give students a real-life experience. Additionally, we allow students of all levels to request an opportunity to job shadow a healthcare professional. In the past, students have observed lab techs, radiology techs, therapists, nurses, doctors and mid-levels in their daily activities of providing care for patients. Our CEO and Foundation Director serve on two Montana healthcare-related scholarship committees. Their participation on these committees promotes healthcare-related careers by helping to fund college educations.</p>

In addition to serving Fallon County, located in southeastern Montana, FMC also provides health care for three bordering Montana counties (Carter, Wibaux, and part of Custer) and three adjacent North Dakota counties (Slope, Golden Valley, and part of Bowman). Considered "frontier" by the Montana Department of Public Health and Human Services, this region boasts less than two residents per square mile. FMC operates a critical access hospital, a rural health clinic, and a home care and personal services agency. Although Carter County operates a Critical Access Hospital and a Rural Health Clinic in Ekalaka, MT (35 miles to the south), facilities offering the next highest level of care are over 80 miles from Baker, necessitating a drive of nearly two hours in inclement weather. Two primary care physicians and two mid levels (physician assistants and/or family nurse practitioners) practice full time in Baker and see patients two days a week in our satellite clinic in Wibaux, MT. In addition, FMC's physicians supervise physician assistants in Ekalaka, MT and in Wibaux, MT. All in all, the DHHS Bureau of Primary Health Care has designated FMC's service area as a Health Professional Shortage Area (HPSA) due to: a) a high population-to-physician ratio (greater than 3,500:1), b) the extreme remoteness of this facility, c) sparseness of our service area, and d) excessive distances to alternative providers. The majority of patients in FMC's service area are Caucasian (96%), older than age 45 (52%) and have graduated from high school (96.2%). The per capita income is about \$31,902 per year (compared to \$27,309 for all of Montana) and the unemployment rate is 1.3% (compared to 3.8%). About 8.5% of the population is below the Federal Poverty Level and roughly 6.5% of the population does not have health insurance. Of those with health insurance, 22% are covered by Medicare, and 6% are covered by Medicaid. Of those people on Medicaid, 21% receive mental health services. In all, according to a Robert Wood Johnson Foundation study, Fallon County is ranked 3 out of 47 for "health factors," based on health behaviors, clinical care, social and economic factors, and physical environment. Like most rural Montana areas, FMC's service area economy is largely based on agriculture. Wheat and barley are major farm crops and cattle and sheep dominate the local livestock production. The other major contributor towards the local economy is oil and gas exploration and extraction. Many residents are employed by large energy exploration and drilling companies or smaller energy-related service companies. The area recently entered the alternative energy arena when wind farms began cropping up across the wind-swept prairie.</p>

They are not compensated for their participation on the board and must be interested in, and willing to work towards, the best interests of health care in our service area. The board strives to find trustee candidates from all corners of FMC's service area, as well as diversity in gender and occupations. The Board is comprised of individuals who work as educators, ranchers, small business owners, retirees, and oil company managers. One of the board's responsibilities is to maintain and oversee FMC's Medical Staff. As such, they are responsible for granting privileges to qualified physicians and mid-levels (providers) based on education and skills confirmed through a structured credentialing process. The board extends medical staff privileges to all qualified providers that have an interest in providing services to our patients and who complete our formal application process. This process includes conducting due diligence through background checks, verification of education and credentials, and personal and professional reference checks. Providers may offer their services directly in our community or remotely via telemedicine systems. Given the isolated rural location of FMC as well as its limited service area population, the facility typically does not generate surplus funds from operations. A delicate balance exists between forecasting an anticipated revenue stream and attempting to match up operational expenses. Given that no revenue is guaranteed, adjustments must be made throughout each fiscal year to ensure the facility's ongoing solvency. Accordingly, FMC has not realized a net profit from operations for over 20 years. Most "surplus" funds are derived from gifts, grants, and fundraising efforts, all of which are generally focused on acquiring capital for the acquisition of patient care equipment. Some of these purchases are meant to upgrade equipment that has reached the end of its useful life cycle, in which case we strive to leverage design or technology improvements to provide greater comfort and effectiveness for the benefit of our patients. And in some cases, we use the funding to start a new service which was identified through our various needs assessments. FMC is predominantly a sole community "primary care" provider for its service area. It is a system, or complex, of health care services was created out of necessity due to its remoteness. FMC lacks the resources and service area population to offer specialized medical services and/or conduct formal medical education and medical research. For the most part, we have striven to incrementally improve and enhance our core service offerings in an effort to increase the overall health status of our patients and residents. Accordingly, we strive to excel at primary care, offering family practice and preventative health outpatient services, routine hospital and fully digital diagnostic services, 24-hour emergency care (available to all regardless of ability to pay), long-term care, home-based skilled and personal care, and physical and occupational therapy. FMC is a sole community "primary care" provider, operating a 24-hour emergency room available to all patients regardless of an ability to pay. Its ER includes a telemedicine connection to the Avera eCare Network which offers on-demand board certified physicians on call 24-hours a day. In an effort to provide comprehensive medical care to the community, various providers from neighboring communities routinely offer services to patients at FMC. For instance, chiropractic, dental, and hearing aid clinics are held regularly in Baker. In addition, FMC's primary medical care is augmented by visiting physicians such as Obstetricians and Pediatricians. In addition, our Telemedicine system is routinely used by participants in a Chemical Dependency (CD) support, education, and life skill class, allowing participants to interact with other participants and counselors in neighboring communities without having to drive for more than an hour each way multiple times each month. It is also used to conduct Healthy Lifestyles classes in conjunction with Holy Rosary Healthcare in Miles City, MT and to connect our patients with specialists located at Billings Clinic. Although we are not a formal teaching facility, we do host multiple students annually who are seeking careers in healthcare related disciplines. This includes high school students who would like to job shadow, to medical students who are completing a primary care rural rotation. We have a number of cooperative agreements with colleges and universities across the nation that allow students a variety of clinical experiences, from observation of care by a trained professional to providing limited patient services under direct supervision. In the past few years, we have hosted students pursuing careers as nurses, lab techs, radiology</p>

Part VI, Line 5:	<p>gy techs, physician assistants, physical therapists and physicians, coming from Pennsylvan ia, Washington State, Florida, Utah and Montana.In addition, FMC's Hospital Helpers organi zation has 30 members who volunteer their time by fundraising for various projects, workin g in our long term care area -- operating a beauty shop, visiting with residents, and prov iding assistance with activities -- and managing a small gift shop in the hospital. All of the money raised by this group is gifted to the facility for the purchase of essential fu rniture, fixtures, and equipment. The community also provides 36 specialty volunteers who offer their talents to our facility. For example, various music groups provide events thro ughout the year and clergy from surrounding churches hold regular church services and help with special needs. Volunteers also read newspapers and books, hold bible study classes, and decorate rooms and hallways for our residents.FMC operates a foundation that exists so lely to attract and manage funds from donors who would like to provide financial support i n the furtherance of FMC's mission. This separate non-profit entity is governed by its own Board of Directors, which raises the funds, manages the investments, and determines how t he funds should be spent. One of their most actively managed efforts is the awarding of sc holarships to students from our service area seeking healthcare careers.We also encourage our staff to be involved in community-related boards and programs. For instance, our Found ation Coordinator has been a member of a local housing board, searching for ways to addres s our community's chronic housing shortage, as well as a county-supported economic revital ization team, and the local chamber of commerce. Furthermore, a number of employees partic ipate in disaster preparedness meetings through the Local Emergency Preparedness Committee and provide leadership roles in Boy Scouts, 4H, Business Professionals of America, Medica l Explorers and Speech and Drama.Lastly, FMC participates in many government-sponsored hea lth care programs, including Medicare, Medicaid, Champus/Tricare, CHIP, and VA Choice. Plu s, we recently agreed to participate in the newly expanded Medicaid program (HELP) offered in Montana. We have also embraced participation in a number of voluntary government-spons ored programs that focus on quality assurance and process improvement, both independently, as well as through collaborative efforts with other Montana hospitals and associations (s uch as the Montana Health Network, the Montana Hospital Association, the Mountain-Pacific Quality Health Foundation and the Hospital Improvement Innovation Network).</p>

This plan identified three goals, to be supported with a number of strategic initiatives: Goal # 1: Improve population health in F MC's service area, by working to enhance chronic care services and prevention outreach. Goal #2: Enhance behavioral health services (mental, behavioral, SUD) in FMC's service area, initially by assessing gaps in current services, then seeking out opportunities for improvements. Goal #3: Improve access to health care services and enhance continuity of care at F MC by increasing access to both specialty and primary care services, as well as improving community education and outreach. The actions taken to address the needs included: Goal # 1: Improve population health in FMC's service area, by working to enhance chronic care services and prevention outreach. We have been striving to enhance participation in a Chronic Care Management HRSA grant offered by the Montana Health Network (MHN). Accordingly, our patient enrollees increased from 2 to 11 during FY2020. This program has received additional funding to continue it for at least two more years. Furthermore, we continued to offer Lunch &amp; Learns on relevant topics, including chronic disease management, during the winter months, and the MHN HRSA grant provided chronic care outreach materials for patient distribution. Goal #2: Enhance behavioral health services (mental, behavioral, SUD) in FMC's service area, initially by assessing gaps in current services, then seeking out opportunities for improvements. We did convene community stakeholders to assess available behavioral, mental, and SUD resources, gaps, and opportunities. Unfortunately, our lead employee moved out-of-town and then Covid-19 hit us, which changed our priorities. We did, however, agree to participate in a separate behavioral health grant through the Montana Health Network, which is currently developing the scope of their project. They have arranged for a Bozeman physician to work with patients remotely over telemedicine, which we intend to utilize as we see a need. We have continued to explore alternative models of provider staffing in our clinic too. Unfortunately, we experienced turnover and extended leave of absence by providers, which required us to adversely increase our use of locums. We have appointed an employee to work with the clinic to define workflow processes and propose alternatives of how to improve them. Lastly, we are taking another run at redesigning our website to make it more user-friendly and patient-focused. We intend to increase the amount of information about healthcare related resources, including our own services, and a more effective calendar of upcoming programs. FMC chose not to address the following needs identified during the CHNA process: 1) CHNA focus groups felt that healthcare costs seemed higher at FMC than other hospitals in the region. Hospitals cannot collude to fix prices, which is a federal trade offense. To do an arms-length pricing analysis, we purchased a database of peer group aggregate pricing from our accountants for hospitals located within our region. This database helped us understand where our pricing might be higher than our competition. In addition, all hospitals are required to post their Charge Master on their websites, which can be accessed for price comparisons. 2) About a third of our survey respondents indicated that they did not know or were unsure of programs that assist people with paying their healthcare bills. We offer a financial assistance program for those with a demonstrated need, as do various community partners (such as Council on Aging and philanthropic organizations.) We intend to include a list of potential programs in the resource manual to be developed under our Implementation Plan. 3) Less than 10% of survey respondents indicated that they were unable to get or take their medications regularly due to cost. We offer a 340(b) program that provides low-cost assistance with medication expenses in collaboration with Baker Rexall Drug. Qualified patients must demonstrate a need, from which they receive a discount card that entitles them to significantly lower pricing on many medications. 4) Housing was discussed as a concern at all focus groups. Unfortunately, we cannot address or resolve the issue of housing. We, too, experience a hardship while trying to recruit staff members and providers. We have explored building our own housing, but persistent annual operating losses have prevented us from accumulating the required capital.
