Form 990, Part X, line 25, column B:	On April 20, 2020, the Foundation received loan proceeds in the amount of approximately \$31,840 under the Paycheck Protection Program ("PPP"). The PPP, established as part of the Coronavirus Aid, Relief and Economic Security Act ("CARES Act"), provides for loans to qualifying businesses for amounts up to 2.5 times of the average monthly payroll expenses of the qualifying business. The loans and accrued interest are forgivable after eight or twenty-four weeks as long as the borrower uses the loan proceeds for eligible purposes, including payroll, benefits, rent and utilities, and maintains its payroll levels. The amount of loan forgiveness will be reduced if the borrower terminates employees or reduces salaries during the eight-week period. The unforgiven portion of the PPP loan is payable over two years at an interest rate of 1%, with a deferral of payments for the first six months. Although the Foundation believes they have used the proceeds for purposes consistent with the PPP, to be conservative, the Foundation elected to follow ASC 470 and record the loans as a liability until the Foundation is legally released or the loan is repaid.
