The Foundation was established to raise, receive and administer donations for the College by building relationships with donors and directing fundraising efforts. All contributions to the Foundation are transferred or spent to directly to benefit the College's students, educational and staff development programs, capital projects and other critical financial needs

Capital building project expenditures consisted of cash transfers to the College to support construction of the new Midland Center. The new center is replacing an aging facility with state-of-the-art technology in downtown Midland. It is conveniently located near major roadways and public transportation making this location more accessible to the students we will serve. Students living in the greater Midland area will have an opportunity to earn a degree in several programs very close to home. The new downtown Midland Center is scheduled to open for classes in August 2021 with an anticipated enrollment of 400- 500 students.

4b (Code:) (Expenses \$ 779,677 including grants of \$ 651,993) (Revenue \$ 0)

Educational program expenditures included equipment purchases and transfers of donated cash and supplies. Cash transfers to the College were used to provide students with scholarships and awards and to enhance educational programs and athletic team needs. The Foundation also published two issues of a magazine to highlight programs, events and educational opportunities at the College. This magazine was mailed to residents in the Great Lakes Bay Region. These expenditures benefitted the entire college community of 11,800 students and staff, and the residents living in the surrounding communities.

Endowment Fund expenditures consisted of cash transfers to the College for investment into the College's Endowment Fund. Revenues generated by the fund provided approximately 420 scholarships and awards during the year. It also supported numerous educational programs such as the Possible Dream Program, STEM education, motivational speakers, public broadcasting and several teaching chairs. The scholarships and programs benefitted the entire College community of 11,800 staff and students as well as the residents living in the entire Great Lakes Bay Region.

All funds transferred from the Foundation to the College are segregated in the College's accounting system and are regularly monitored to ensure they are used for the purposes intended, including investments into the Endowment Fund. Foundation staff also coordinate the process of selecting students to receive the scholarship funds raised by the Foundation.

Non-academic student assistance expenditures included payments for rent, utilities, car repairs, bus passes, groceries and warm winter boots and gloves totaling \$26,946. This aid was provided to benefit Delta College students attending classes who had barriers that were threatening their ability to complete their courses. All of the students who received aid were referred by College staff and the Foundation paid the service providers directly on behalf of the students. This non-academic emergency assistance helped approximately 500 students.

Form 990, Part IV, Line 32.

The Foundation's net assets decreased from \$10,776,337 to \$7,176,098, or 33%, during the year, as shown in Part X, due to cash transfers to the College. Although this amount exceeds 25%, Schedule N instructions state that "Grants or other assistance made in the ordinary course of the organization's exempt activities to accomplish the organization's exempt purpose" do not need to be reported, so the "no" box was checked. The decrease was the result of transferring funds to the College for the purpose of constructing the new Midland Center building.

Four automobiles were donated to the Foundation by car dealerships. We were not required to issue Forms 1098-C because these vehicles were part of their sales inventories, which is their "ordinary course of business." The vehicles were transferred to the College's Technical Trades and Manufacturing Division to use in the automotive service curriculum.

The Form 990 and the Audited Financial Statements were distributed to the members of the Board of Directors serving on the Finance Committee. The committee reviewed the materials to prepare for a meeting with the Executive Director, the Treasurer and the Accountant who prepared the Form 990. This meeting provided the committee members with an opportunity to question, amend and approve the content of the Form 990 prior to submitting it to the IRS. The members of the committee reported the results of the meeting to the full Board of Directors at their next quarterly meeting. Any conflicts would be brought to the attention of the Board Chair and the College President who serves as an Officer on the Foundation Board.
