THE TRAINING CURRICULUM REFLECTS THE SKILLS AND EXPERIENCE THAT LOCAL FOOD SERVICE EMPLOYERS ARE SEEKING. FOOD GATHERERS ALSO OFFERS PAID INTERNSHIPS AT THE WAREHOUSE OR THE KITCHEN TO GRADUATES. DURING THE YEAR ENDED JUNE 30, 2020, THREE STUDENTS GRADUATED FROM THE PROGRAM.
