Our Sharing Center distributes diapers, infant formula, maternity clothes, baby equipment, and other related items free of charge. During the 2019-2020 fiscal year, we met with an average of 231 clients per month and distributed approximately 100,000 diapers in total until pandemic restrictions compelled us to close our sharing center temporarily.

Our Baby Care Package program provides supplies through the first two years of an infant's life. Packages are delivered at the hospital if possible or to the home. This program delivered 152 gift packages containing baby blankets, outfits, bottles, books, and toys to mothers of newborn children.
