WPR's mission is to serve the entire state of Wisconsin by producing, acquiring and delivering high quality radio programming that serves the public's need to discuss ideas and opinions and that provides cultural enrichment, intellectual stimulation and intelligent, enlightening entertainment throughout the WPR network. WPR reports nearly 500,000 listeners per week and over 54,000 contributors. WPR broadcasts from 34 stations throughout the state and streams live online to provide programs for its 3 networks: the Ideas Network, the NPR News and Classical Music Network, and the 24-hour HD Classical Music Network.
