MICHAEL'S HOSPITAL OPENED THE DOORS AT THE CANCER CENTER FOR MEDICAL ONCOLOGY AND RADIATION ONCOLOGY SERVICES IN 1999, THE FOUNDATION CREATED THE FIRST WIG GIFTING PROGRAM DESIGNED TO SUPPORT PATIENTS EXPERIENCING HAIR LOSS FROM TREATMENT. SINCE THEN, THE PROGRAM HAS EVOLVED INTO THE FOUNDATION'S ONCOLOGY FUND WHICH SUPPORTS PROGRAMS, SERVICES AND INITIATIVES TO BENEFIT THE LIVES OF CANCER PATIENTS, SUCH AS WIGS, HATS, GAS CARDS, BLANKETS, EDUCATIONAL MATERIALS AND SERVICES THAT IMPROVE PATIENT EXPERIENCE. ARTICLES OF INCORPORATION OF  
SAINT MICHAEL'S FOUNDATION OF STEVENS POINT, INC.**

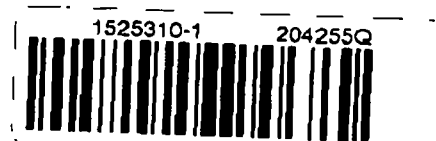
Saint Michael's Foundation of Stevens Point, Inc., a corporation duly existing under the laws of the State of Wisconsin (the "Corporation"), restates and amends its Articles of Incorporation under the Wisconsin Nonstock Corporation Laws (Chapter 181 of the Wisconsin Statutes-the "Act").

**ARTICLE I  
GENERAL**

- 1.1 **Name.** The name of the corporation is Ascension St. Michael's Hospital Foundation, Inc. ("Corporation").
- 1.2 **Organization.** Corporation is organized under Chapter 181 of the Act.
- 1.3 **Definitions.** Capitalized words and phrases not otherwise defined herein shall have the meanings ascribed thereto in the Bylaws of the Corporation.

**ARTICLE II  
PURPOSES**

- 2.1 **Purposes.** The Corporation is organized and shall be operated exclusively for charitable, religious, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as amended (or the corresponding provision of any future United States Internal Revenue Law) (the "Code"), including, for such purposes, the making of distributions in support of Ascension Sponsor to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code. Further, the Corporation is organized and at all times shall be operated exclusively for the benefit of, to perform the functions of, and to carry out the purposes of Ascension Sponsor and such other of its subsidiary organizations that qualify under Section 501(c)(3) and under Section 509 (a)(1) or Section 509 (a)(2) of the Code, by and through the Corporate Member, Ascension Health and Ascension. The Corporation's purposes shall be consistent with and supportive of the corporate purposes of the Corporate Member, Ascension Health, and Ascension, and shall have such other purposes as set forth in the Bylaws. In the course of the operation of the Corporation:
- 2.1.1 No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons unless allowed by Section 501(c)(3) of the Code and the Act except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.
- 2.1.2 No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation



shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

- 2.1.3 Notwithstanding any other provisions of the Corporation's Articles of Incorporation or Bylaws, the Corporation shall only operate for charitable purposes and the Corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

### **ARTICLE III**

#### **DURATION**

- 3.1 **Period of Existence.** The period during which the Corporation shall continue is perpetual.

### **ARTICLE IV**

#### **PRINCIPAL OFFICE**

- 4.1 **Principal Office.** The address of the principal office of the Corporation is: 900 Illinois Avenue, Stevens Point, Wisconsin 54481.

### **ARTICLE V**

#### **REGISTERED AGENT AND REGISTERED OFFICE**

- 5.1 **Registered Agent.** The name of the Corporation's registered agent for service of process is Corporation Service Company.
- 5.2 **Registered Office.** The address of the Corporation's registered agent for service of process is 8040 Excelsior Drive, Suite 400, Madison, WI 53717.

### **ARTICLE VI**

#### **MEMBERSHIP**

- 6.1 **Member.** The corporate member of this Corporation is Ascension St. Michael's Hospital, Inc., a Wisconsin nonstock and not-for-profit corporation (the "Corporate Member"), which is an indirect subsidiary of Ascension Health. The powers, duties, rights and responsibilities of the Corporate Member are as provided for and determined in the Bylaws of this Corporation.

### **ARTICLE VII**

#### **AMENDMENT**

- 7.1 **Amendment of Articles of Incorporation.** These Amended and Restated Articles of Incorporation may be amended or restated in the manner provided in the Corporation's Bylaws.

**ARTICLE VIII**  
**PROVISIONS FOR REGULATION AND CONDUCT OF THE AFFAIRS OF**  
**CORPORATION**

- 8.1 **Bylaws.** The Bylaws of the Corporation may contain any provision for the regulation and management of the affairs of the Corporation not inconsistent with applicable law of the Wisconsin.
- 8.2 **Disposition of Assets upon Dissolution.** Upon the dissolution of the Corporation, the disposition of all the assets of Corporation shall be in a manner as provided by the Board (subject to the prior approval of Ascension Healthcare) and in accordance with the following:
- 8.2.1 The paying of or the making of provision for the payment of all of the liabilities, direct or indirect, contingent or otherwise, including without limitation, all liabilities evidenced in all outstanding loan agreements, credit agreements, master indentures and other similar documents.
- 8.2.2 Subject to compliance with the dissolution principles of Corporate Member, all assets remaining after the payment of all of the liabilities of the Corporation shall be distributed to Corporate Member or to such other exempt organization(s) under Section 501(c)(3) of the Code as shall be determined by Ascension.
- 8.2.3 Any other assets not so disposed of shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
- 8.3 **Distributions.** Subject to limitations or requirements set forth in the System Policies or approval rights otherwise reserved to Ascension Health, the Corporate Member may direct the Corporation to make distributions, donations, loans or other actions allowed under Section 181.1302(3) and/or Section 181.1302(4) of the Act, in order to promote the interests of any nonprofit and federally tax-exempt organizations or the interests of any other health-related organizations which, if not federally tax-exempt organizations, are operated in every manner as if they were in fact federally tax-exempt organizations, or which are the Corporate Member, Ascension Health, Ascension, Ascension Health Ministries, a public juridic person ("Ascension Sponsor"), or any organization affiliated with the Corporation, the Corporate Member or Ascension Sponsor, and which further the purposes of Ascension Sponsor and of the Roman Catholic Church, the purposes of

which are not inconsistent with those of the Corporation.

The undersigned, being the President of the Corporation, declares and certifies that:

(a) These Amended and Restated Articles of Incorporation were adopted and approved by Saint Michael's Foundation of Stevens Point, Inc. on June 19, 2020, and by its Corporate Member on June 5, 2020, in accordance with § 181.1030 of the Act to be effective July 1, 2020;

(b) These Amended and Restated Articles of Incorporation were approved in writing by the person whose approval is required by a provision of the articles of incorporation authorized under § 181.1030 of the Act; and

(c) These Amended and Restated Articles of Incorporation supersede and take the place of the existing Restated Articles of Incorporation and any amendments thereto effective as of July 1, 2020.
