THE COUNCIL HELD "OUR TOWN" WORKSHOPS TO SUPPORT A SERIES OF EVENTS THAT FACILITATE ENGAGEMENT WITH THE PUBLIC, TO HELP DEVELOP A VISION OF FUTURE PUBLIC ART PROGRAMS AND COMMUNITY ARTS EVENTS IN DOWNTOWN LITTLE FALLS, MINNESOTA. IN-KIND SERVICES WERE RECEIVED FROM 25 INDIVIDUALS WHO LED OR PARTICIPATED IN STEERING COMMITTEE MEETINGS, SURVEYS AND OTHER, WITH AN ESTIMATED VALUE OF 34,952. THE COUNCIL AWARDED 1 ARTS BASED COMMUNITY DEVELOPMENT (ABCD) GRANT. ABCD GRANTS ARE MEANT TO BE A COLLABORATION BETWEEN ARTISTS, DESIGNERS, ARTS ORGANIZATIONS AND COMMUNITY LEADERS TO DELIBERATELY INTEGRATE ARTS AND CULTURE TO ADDRESS ISSUES FACING THE COMMUNITY. THE COUNCIL AWARDED 2 GRANTS TO 2 ORGANIZATIONS FOR SMALL GRANTS. SMALL GRANTS ARE INTENDED TO SPONSOR AN ARTS ACTIVITY OF A FIRST TIME ARTS PRODUCER OR PRESENTER, OR A SUDDEN OPPORTUNITY OF A PREVIOUSLY FUNDED APPLICANT. THE COUNCIL AWARDED 7 SCHOOL ARTS PROJECT GRANTS TO 4 SCHOOLS TO ADVANCE ARTS EDUCATION IN FIVE WINGS AREA SCHOOLS THROUGH ARTIST-TEACHER PARTNERSHIPS; TO CONVEY TO STUDENTS AND TEACHERS THAT THE ARTS ARE ESSENTIAL TO EDUCATION AND DAILY LIFE; AND TO HELP STUDENTS LEARN IN THE ARTS AND LITERATURE. QUALIFIED ARTISTS WORK WITH TEACHERS IN EDUCATIONAL SETTINGS TO REINFORCE STUDENT'S CRITICAL THINKING, SELF-DISCIPLINE, AND CREATIVE SELF-EXPRESSION.
