WHENEVER A MEMBER HAS CAUSE TO BELIEVE HE OR SHE IS INVOLVED IN A MATTER TO BE VOTED UPON, THE MEMBER SHALL ANNOUNCE THE CONFLICT OF INTEREST AND ABSTAIN FROM VOTING ON SUCH A MATTER. AFTER A BOARD MEMBER ANNOUNCES THAT A POSSIBLE CONFLICT OF INTEREST EXISTS, THE ENTIRE BOARD SHALL DECIDE WHETHER AN ACTUAL CONFLICT OF INTEREST EXISTS BY A VOTE OF THE MAJORITY. THE MEMBER IN QUESTION AND ANY OTHER MEMBERS PRESENT WHO HAVE ALREADY BEEN DISQUALIFIED FROM VOTING ON THE ISSUE BECAUSE OF THEIR OWN CONFLICT OF INTEREST SHALL BE EXCLUDED FROM VOTING ON THE QUESTION.
