DISTRIBUTIONS (UP TO 100% OF THE FUND BALANCE) OF THE FUND IS PURSUANT TO REQUESTS OF THE AGENCY SUBMITTED IN WRITING AUTHORIZING SUCH DISTRIBUTIONS. THE RESOLUTION SHALL STATE THE SPECIFIC REASON(S) FOR THE REQUEST AND DESCRIBE WHY SUCH DISTRIBUTION WOULD FURTHER THE LEGITIMATE INTERESTS OF THE AGENCY AND HOW THE FIDUCIARY RESPONSIBILITIES TO PRIOR CONTRIBUTIONS WILL BE FULFILLED. ANY SUCH DISTRIBUTION OF THE FUND'S PRINCIPAL, IN WHOLE OR IN PART, SHALL BE SUBJECT TO THE APPROVAL OF THE FOUNDATION'S BOARD OF DIRECTORS, WHICH SHALL NOT BE UNREASONABLY WITHHELD, AND WILL BE MADE WITHIN 90 DAYS OF THE REQUIRED APPROVALS. THE FOUNDATION PROVIDES A WRITTEN STATEMENT TO THE AGENCY NO LATER THAN 30 DAYS AFTER THE END OF EACH QUARTER SHOWING THE PERFORMANCE AND ACTIVITY OF THE FUND. THE FEE TO ADMINISTER THE INVESTMENTS BY THE FOUNDATION IS .5% OF THE MARKET VALUE OF THE FUNDS ASSETS AT THE FISCAL YEAR-END.
