Explanation: March 12, 2021 To Whom It May Concern: Today I called and spoke with Mike, IRS Badge #1000144381. He was extremely helpful as I explained the circumstances which prevented the filing of our 501c return in a timely manner. He recommended that I write this reasonable cause letter and I am doing so. I am a parent volunteer for the BRIAR WOODS ATHLETIC BOOSTERS CLUB INC. I am writing to request that the penalties and any interest from our organization's late June 30, 2019 filing be removed. (IRS notice CP141L) In September 2019, my father was diagnosed with cancer. I was immediately immersed in helping with doctor's appointments, medications, and seeing to his care and welfare. Two months later, he was diagnosed with a second cancer - this one a rapid growing brain tumor that his doctors told us was terminal. My father underwent brain surgery in November 2019 to remove as much of the brain tumor as they could. In January 2020, he started radiation treatments several times a week. This was an extremely stressful and emotional period for me. My father passed away in March 2020 and then I had my 75-year old mother to care for while the COVID-19 pandemic wreaked havoc in public and personal life. One effect of the pandemic was that our high school, Briar Woods High School, in Ashburn Virginia was closed to students and volunteers from March 12, 2020 to March 3, 2021. I was unable to retrieve any of the mail for our organization during this time. All the mail comes to our high school address - 22525 Belmont Ridge Road, Ashburn, VA. The IRS notice CP141L that was dated July 6, 2020 and accordingly mailed to the high school, did not reach me until March 2021, when volunteers were able to enter the high school and we were able to get our mail. Please understand the extreme circumstances of my father's cancer, death, and the COVID-19 pandemic closing our high school for 12 months, all combined to prevent me from filing the Form 990EZ before its due date.
