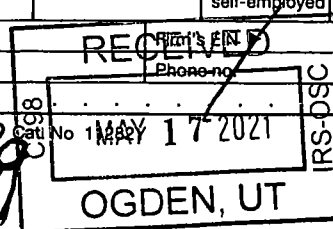

- 1) Form 990, Part I, Question 1 - VICC's primary exempt purpose is to administer a voluntary public school desegregation (student transfer) program on behalf of participating public school districts in St. Louis City & County pursuant to the 1999 Desegregation Settlement Agreement by order of the Federal Court (Eastern District). To fulfill this purpose, VICC handles all 1) recruitment, 2) transportation to/from school, and 3) tuition reimbursement payments to participating school districts. Funding is derived primarily from the State of Missouri.
- 2) Form 990, Part III, Question 1 - VICC administers a public school desegregation program involving 13 different public school districts in St. Louis City and County pursuant to the 1999 Desegregation Settlement Agreement by order of the Eastern District Federal Court. About 3,728 students participated during 2019/20. VICC recruits and transports students and pays school districts a tuition amount for each transfer student enrolled. Funding is derived primarily from the State of Missouri.
- 3) Form 990, Part V, Question 2a - The ten VICC employees were reported by VICC's Common Paymaster, Education Plus.
- 4) Form 990, Part VI, Question 3 - As described on Schedule J, Part III, the CEO responsibilities are provided by TransPar, Inc., an unrelated organization. In addition, TransPar, Inc. also provides oversight and management of the transportation of students. Fees paid to TransPar are listed in Part VII, Section B.
- 5) Form 990, Part VI, Question 6 - VICC is organized as 501(c)(3) nonprofit corporation governed by a Board of Directors consisting of one representative (the superintendent or designee) from each participating public school district (member), which for 2019/20 was the 13 public school districts listed in Schedule I, Part II, Question 1(a).
- 6) Form 990, Part VI, Question 7a - The Board of Directors is the governing body of VICC. Since the Board consists of a representative from each participating district (member), the Board's decisions/actions are not subject to approval by any other persons or organizations. Pursuant to VICC's By-Laws, each representative has a proportional vote based on the number of desegregation/transfer students it enrolls. A Board President, Vice-President and Treasurer are elected by the Board from among its members each year.

Monthly financial statements are included in open meeting materials and are available to the public upon request or during regular business hours from 9:00 a.m. to 2:00 p.m. weekdays at the VICC organization office. Governing documents, including formal Board policies are posted on the VICC website and are also available to the public on the same basis free of charge.
