The Counseling program saw 400 clients during the year and provided 2,549 counseling sessions. They also provided marriage preparation workshops for 97 couples. The organization received \$29,549 in grant funding due to COVID-19; \$14,000 of this was used towards financial assistance to individuals and the remainder was used to supplement lost revenue and continuity of operations.
