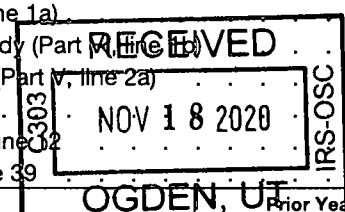

The committee then reviews the organization's performance and strategic plan goals to develop an incentive compensation plan in addition to base salary. Compensation for executive management includes performance appraisal completed by the President/CEO or the employee's direct supervisor. Employees are eligible for annual inflationary increase to their base salary. The percentage is based upon an approved annual budget or other board approved changes. The ND Long Term Care salary surveys are reviewed and adjustments are made to the base salaries of identified positions if the survey demonstrates underpayment compared to like sized organizations.
