This student-led club model equips students with the resources and tools to change their school culture around mental health. The Organization is unique from other peer-to-peer programs in that it offers customized support, a bank of club resources including 70+ mental health activities and multiple opportunities for student connection through social media, leadership training and internship opportunities. OMM's primary outcomes are increasing help-seeking behavior, promoting social connectedness and encouraging the development and use of healthy habits and coping skills among students, all of which are critical protective factors for suicide prevention.

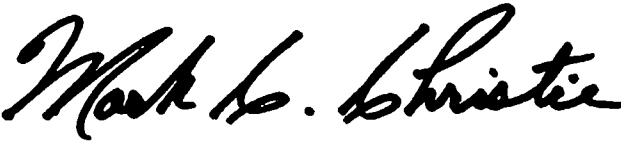

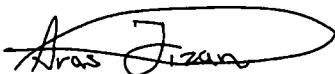

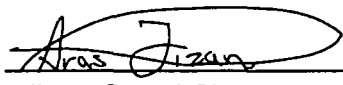
