TO MEET THIS NEED, THE FOUNDATION SUPPORTS THE UNIVERSITY OF NORTHERN IOWA (UNI) DIGITAL MEDIA LEADERSHIP PROGRAM. THE PROGRAM WILL BE AN EMPHASIS WITHIN THE UNI DIGITAL MEDIA MAJOR AND NOW MINOR. THE DIGITAL MEDIA LEADERSHIP PROGRAM CURRICULUM, DEVELOPED THROUGH COLLABORATION BETWEEN UNIVERSITY FACULTY AND IOWA BROADCASTERS, EMPHASIZES MEDIA TRENDS, ECONOMICS, MARKETING AND STRATEGIC PLANNING ALONG WITH A COMPREHENSIVE CORE IN DIGITAL MEDIA. GRADUATES WILL BE PREPARED TO PROVIDE DIRECTION TO ELECTRONIC MEDIA OF THE FUTURE. IT IS EXPECTED THAT ANNUALLY 15-20 STUDENTS MAJORING IN THE UNI DIGITAL MEDIA LEADERSHIP PROGRAM WILL EACH BE ELIGIBLE TO RECEIVE A 2,500 SCHOLARSHIP FOR THE ACADEMIC YEAR, FUNDED BY THE IBA FOUNDATION, WITH OPPORTUNITIES FOR ADDITIONAL SCHOLARSHIPS IN THE FUTURE AS IBA FOUNDATION FUNDS PERMIT. ALL IBA FOUNDATION SCHOLARSHIP GRANTS ARE MADE PAYABLE DIRECTLY TO THE UNIVERSITY OF NORTHERN IOWA FOUNDATION FOR THE SELECTED STUDENT'S BENEFIT. RECIPIENTS OF THE SCHOLARSHIPS ARE SELECTED BY THE UNIVERSITY.
