28	In Hands and Feet of Asheville's primary program, serving as the Asheville site of the Presbyterian Church (USA)'s Young Adult Volunteer program, the organization hosted 4 young adult volunteers here in Asheville, each engaging in 32 hours per week of service. In normal program years, the YAVs serve for 11 months, from September through July of the following year. However, in the 2019-20 program year, the Board of Hands and Feet of Asheville voted to suspend our volunteers' in-person service from mid-March through July, due to the global COVID-19 pandemic impacting the United States and Asheville. From September 2019 through mid-March 2020, the YAVs volunteered for approximately 25 weeks, totaling more than 3,200 hours of service, and more hours were achieved from mid-March through July in certain volunteer positions that allowed some remote service. Their community impact included an estimated 94 move-ins for people who were previously without a home, and 150 donation pick-ups, through Homeward Bound's Welcome Home Project; providing daily support, services, and companionship to Asheville's diverse homeless population in Homeward Bound's AHope Day Shelter program; serving as a community liaison and administrative support for a number of Asheville Area Habitat for Humanity's home repair program for underserved populations in Asheville; and supporting the Haywood Street Congregation's various ministries feeding, clothing, and providing authentic and dignified companionship for people living without permanent shelter in Asheville, as well as providing technical assistance for virtual services remotely after mid-March. Our volunteers engaged in personal, spiritual, and professional growth throughout over 40 "Friday morning meetings" led by Hands and Feet Executive Director Selena Hilemon (including increased time together virtually after YAVs left Asheville, continuing support and contact), supported by HFA board members and community leaders and specialists, exploring the volunteers' work experiences, YAV house community-building and strengthening, current events, topical experts and social justice related reading, individual relationship styles, conflict resolution, and more; experienced Orientation/Welcome activities plus 2 multi-day retreats throughout the program year focused on vocational discernment, the work of intentional communities, and spiritual exploration; participated in at least 25 weeks of carefully coordinated meal planning, budgeting, and preparation within their YAV house community while striving for a central "simple living" goal; participated in regular One-on-One volunteer and Executive Director sessions throughout the program, both planned and on an as-needed basis. Our program expenses represented here include costs of renting living space for the volunteers at Brooks Howell Home, paying the volunteers a modest living stipend per month, providing orientation to Asheville and retreats away from Asheville, food and programming surrounding every Friday morning meeting, one-on-one session, community partner check-in, and any associated travel expenses, including additional expenses this year of evacuating YAVs from Asheville mid-March due to the COVID-19 global pandemic, for the remainder of their program year. NOTE: Hands and Feet delivers one central program category -- as such, our Executive Director provides a crucial role of expertise, communication, support, and organization for our Young Adult Volunteers and our nonprofit community partner worksites, alike. The employment expenses related to the ED are not represented here this program category, but to be clear, most of her time is dedicated to the ongoing operation of the program and interpersonal work required to facilitate this challenging and rewarding year for our volunteers.
