UTILIZING THIS D IGITAL CONTENT AND MULTIPLE QUALIFIED TEACHERS IN EACH CLASSROOM, INGENUITY PREP IS ABLE T O CONSISTENTLY PROVIDE ACCOUNTABLE, PERSONALIZED, INDEPENDENT AND SMALL-GROUP LEARNING EXP ERIENCES. WITH A TEACHER-STUDENT RATIO UNPARALLELED BY MOST OTHER SCHOOLS IN THE CITY, AT INGENUITY PREP, EACH CLASSROOM IS SUPPORTED BY BETWEEN 2-3 HIGHLY-QUALIFIED TEACHERS - FRO M PREK THROUGH ELEMENTARY SCHOOL. INGENUITY PREP'S TEACHERS ARE SPECIALIZED (I.E., THEY TE ACH A MORE FOCUSED SET OF CONTENT THAN TRADITIONAL TEACHERS).
