Once confirmed, the business office staff requests reimbursement from the respective awarding agency. For scholarships, financial aid office staff reviews the specific criteria for awarding to students. The business office staff does a reconciliation of expenses (financial aid awarded) before drawing down actual dollars from the endowment and federal financial aid. For program endowments, there are two different methods used. Some programs have "budget managers" who are aware of the funds available via the business office staff and spend accordingly. For those programs without "budget managers and for unrestricted endowments, the business office staff ensures that there are expenses incurred in those specific departments before drawing down actual dollars. In all cases for the endowments, the business office staff does a reconciliation to ensure that the proper dollar amount is calculated, awarded/expensed, and drawn down.
