THE HOSPITALITY HOUSES PROVIDE SHELTER FOR FAMILIES TRAVELING TO SIOUX FALLS TO VISIT AN INCARCERATED LOVED ONE. THIS SERVICE ALLOWS FAMILIES, WITH LIMITED INCOMES, TO CONTINUE THE HEALING PROCESS WITH THE INCARCERATED FAMILY MEMBER. CHILDRENS CONNECTION, A UNITED WAY AGENCY, WORKS WITH THE SIOUX FALLS SCHOOL DISTRICT TO PROVIDE GROUP COUNSELING SERVICES TO CHILDREN WITH AN INCARCERATED FAMILY MEMBER. CHILDREN WITH A PARENT IN PRISON ARE MORE LIKELY TO BE INCARCERATED THEMSELVES. FAMILY CONNECTION, THROUGH THE CHILDRENS CONNECTION PROGRAM, IS WORKING TO BREAK THIS CYCLE.
