INVESTIGATING: AMCHA Initiative released two groundbreaking reports detailing antisemitic activity on U.S. campuses. The first report explored the causes of Jewish student harassment which found that the academic boycott of Israel is inciting a rise in harassment of Jewish students on campuses across the country. The second report examined 50 syllabi at 40 public and private colleges and universities over an eleven-year period and provided the first empirical evidence suggesting that faculty who support academic BDS are actively promoting that political agenda directly to students in their classrooms. **DOCUMENTING:** As the only publicly-accessible, user-friendly database of antisemitic activity on more than 400 campuses nationwide, AMCHAs website is an invaluable resource for university stakeholders, allied organizations, state and federal legislators and scholars, with 3,500 5,000 page views a month. During this reporting period, AMCHAs Antisemitism Incident Tracker documented over 485 incidents on 188 campuses, which included 87 incidents of genocidal expression. AMCHA additionally documented 111 publicly-available quotes of Jewish students experiencing antisemitism on 43 campuses. **EDUCATING:** During this period, AMCHAs data, studies and efforts were cited in more than 300 articles in outlets that included The New York Times, The Washington Times, CNN, Newsweek, Fox Illinois, The Daily Wire, The Washington Free Beacon, The Orange County Register, The Forward, The Jerusalem Post, Jewish Telegraph Agency, Jewish Journal and many more. AMCHAs data was further cited in reports produced by The Institute for the Study of Global Antisemitism and Policy, Jerusalem Center for Public Affairs, Zachor Legal Institute, Alumns for Campus Fairness, and the Israeli Ministry of Strategic Affairs as well as in a student resolution at Santa Monica College denouncing campus antisemitism and a student podcast of Students Supporting Israel. During this reporting period, AMCHA sent out 16 bulletins to 10,000 supporters and issued 9 press releases to hundreds of media outlets. **COMBATING:** During this period, AMCHA coordinated and led a coalition of more than 135 religious, civil rights, education and advocacy organizations in urging university administrators to adequately respond to incidents on a number of campuses across the country, including San Francisco State University, the Cal State University System, University of Massachusetts Amherst (U Mass), U Mass Dartmouth, U Mass Boston, New York University and Pitzer College. In addition, AMCHA launched a petition signed by over 3,500 individuals and led the coalition of organizations on a number of campaigns in opposition to a California state-wide ethnic studies model draft curriculum which was highly politicized and contained antisemitic and anti-Israel sentiments throughout. AMCHA furthermore launched a petition for individuals to oppose an academic boycott of Israels implementation on U.S. campuses, which is currently still open, and signed by over 2,500 individuals thus far.
