Unfortunately it slipped through the cracks. We believe reasonable cause exists due to the general disruption caused by the pandemic. Because of the organizations excellent filing history and the fact that the prior year was nothing short of chaos we respectfully request that the late filing penalties be abated and that those funds be allowed to stay in the classroom with our students.
