In cooperation with governmental and non-governmental partners, education efforts continued to increase on the importance of healthy soils for production and sustainability. The Association cooperated with the Sand County Foundation and state sponsors of the Leopold Conservation Award to provide Leopold Award Winners opportunities to share their stewardship story. The Association continued their involvement in raising awareness of renewable energy issues, opportunities and challenges. The Association is considering new opportunities to conduct or assist tree research.

Increase non-operating landowners' (NOLOs) awareness of natural resources conservation measures, benefits and opportunities. The program focuses on interested landowners who own land in South Dakota but do not operate it themselves. Information continues to be provided on a variety of topics & opportunities offered to participate in programs & projects.

The Association registered the executive director and the board of directors president as lobbyists so they might appear before legislative committees on behalf of the Association and its members. During the legislative session, the Association's primary activity was to monitor legislative activities and report on a weekly basis to the Association's membership. This report was in e-mail form sent to each conservation district office and the Association's board of directors. It is a concise report of selected legislation that might be of interest to members and did not usually encourage or solicit action by the conservation districts. The registered lobbyists provided limited testimony 18 times to legislative committees, normally to provide technical information or update the committees on the activities of the conservation districts in assisting with the programs the committees had jurisdiction over. Nationally, the Association kept members informed possible and pending legislation and rules and how they might affect the conservation district's activities. Information received from various groups was usually forwarded to the conservation districts e-mail accounts. In some instances, the Association might provide a brief analysis of the information. The Association encouraged its members to stay informed on political issues and to become engaged, as the member deemed appropriate, in the discussion. The Association's executive director has some contact in the form of e-mail and phone calls with the Congressional offices, primarily at the initiation of the Congressional staff. The Association incurs few expenses in the activity since internet access is used for general operations. The State of South Dakota received \$100.00 for two lobbyist registrations. Staff time was estimated at one hour per week when the SD Legislature was not in session (42 weeks) and 12 hours per week during SD Legislature session (10 weeks) for a total of 163 hours and estimated value of \$7,172 at \$44 per hour.
