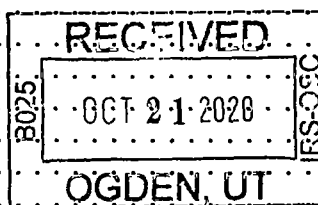

Women's Group and local Cheeba community, identified the business operations that will be supported by the energy providing local jobs, income to the women's group and economic advancement for the Cheeba community. A team of KWH volunteers traveled to Cheeba to oversee the implementation of the kiosk, commission the microgrid system, and support our partners in the establishing of their new solar-powered kiosk.

In Fall 2019, we provided funds to our earliest partner, Symon Warioba of Kristy's Cape Academy (KCA), to recycle his solar and wind-powered microgrid components which had expired in use, namely the station lead-acid batteries. This project was initiated in 2014 and the typical lifespan of batteries are 5 years. In 2019, the KCA energy kiosk had the opportunity to connect to the Kenyan electrical grid which was constructed in the Muhuru Bay community enabling the sustainability of the KCA microgrid to continue to serve the kiosk. This grant to KCA allowed technical equipment to be properly disposed of.

KWH sponsored a Seattle University engineering senior design team to improve upon our data acquisition system (DAS). The DAS is a unique and integral component to ensuring the technical sustainability and health of our solar microgrids. In FY2020, a group of 4 students improved the DAS to improve its functionality and reduce the number of external sensors needed.
